MINUTES

REGULAR COUNCIL MEETING

CALL TO ORDER

Council President VanDamme opened the meeting at 5:30 pm.

ESTABLISH A QUORUM

A quorum was established, and the following members were present: Cathi Van Damme – Council President, Courtney Ignazzitto - Councilor, Mike Shields - Councilor, Karen Morse - Councilor, and Dillon Marston – Student Councilor. Mayor Richer was absent by prior arrangement. The following staff were also present: Geoff Wullschlager - City Manager, Ashley Ivans - Assistant City Manager / Finance Director, Kelly West – Public Works Director, and Brent Bybee – Principal Planner.

PLEDGE OF ALLEGIANCE

Council President VanDamme led the pledge of allegiance.

Courtney Ignazzitto made a motion to approve the consent agenda. Seconded by Karen Morse. Motion was unanimous.

PRESENTATIONS:

1. Platinum Financial Wellness Program for Municipalities – Mr. Ben Cvetkovich

Mr. Cvetkovich introduced himself and provided a presentation and background information on his company Platinum-Age. He discussed how his private sector clients are subject to tax payments, and have a desire for tax relief. As a part of this research his company has found that smaller governments need a higher cash flow.

He provided an overview of how the program works through local governments buying businesses to convert the income into non-taxable income. He discussed the different ways that local governments can gain money i.e., a) bonds, and b) revenue bond. He went on to explain that government entities gain municipal interest which is tax free. He further stated that his program is based on conditional sales agreements. He provided an example of cities owning convention centers through qualified management agreements. He stated that the conditional sales agreements in his program last for 1 year for renewal purposes, and federal regulations. A city can opt out of a sales agreement without penalty based on most state laws. It is important that the City be able to opt out in case of fluctuations in the market. He discussed the default callings of the City and the business. The environment created through his program is designed to create mutual motivation to keep both parties happy.

The structure is expected to be flexible not stringent. Keep businesses out of the local government's home state because a subdivision of the state will create a tax abatement to the state. The exemption only applies to federal tax. Contracts are less than one year and are classified as current assets — typically an off-balance sheet item. Revenue is free and clear, there is no grant reporting. Intent is to provide financial solutions to both parties. The Federal government shouldn't mind not receiving the taxes because the local govt gains a benefit to respond to local service needs.

Form 8083-G allows the city to provide a benefit to businesses to generate tax free interest income.

Geoff said that Tonkin & Torp may counsel us on this item as well as the LIHTC discussions. Council had consensus to table the item until Tonkon Torp LLP has provided an engagement letter.
