As you are all aware, the City of La Pine and its Community Development Department have undertaken a Visioning Process to solicit input from community members on the following open-ended questions:

1. What do you value about La Pine?
2. What are La Pine's disadvantages?
3. What would improve La Pine?
4. What street do you live on?

The Community Development Department has been receiving responses and aggregating the information to inform and identify 4-5 primary goals in preparing for the La Pine Comprehensive Plan Update that is to commence in early 2024.

As advertised through mailers and other outreach efforts, you are gathered to foster public input on these questions and to provide public listening by both bodies for our constituents. Mr. Bybee will be providing a framework prior to our meeting date on the 15th to assist you in this process. There will be no required formal action by either body during the workshop as staff will be preparing the draft goals following both sessions scheduled for November 15th, and November 29th. All that is required is your presence to provide the public with the opportunity to interact with our elected and appointed officials on this long-range planning effort.
