#### 4. <u>Presentation by Scott Langton – County Assessor</u>

Mr. Langston stated that a tax bill is a result of the citizens making a decision to have certain services. He said that prior to 1997 the assessed value was the real market value. Mr. Langton stated Measure 50 capped the permanent rate for value. He said that Central Oregon experienced a huge drop in the market and the taxes went down. Mr. Langton said that the poor economy creates a lot of volatility in the value amounts. He said the City of La Pine has 50% residential and 50% commercial buildings. Mr. Langston stated he predicted a flat rate value for La Pine properties but that is only a prediction at this point in time.

# 6. Budget Message

City Manager Hasson reviewed the Budget Message. He said there was nothing unsatisfactory in the budget reports such as being over budget. City Manager Hasson stated that ODOT (Oregon Dept of Transportation) has been a good friend to the City this year with a number of grants. He said he tried to identify the financial impact for this year that will carry forward to next year with the thirteen priorities that the Council selected.

The committee reviewed a number of questions that were posed in the Budget Message. It was decided to hold off on changing the tax rate until the budget had been reviewed in detail. Mayor Mulenex stated that the two parcels that are referenced about in the Budget Message are for the Council to deal with. He also said, regarding the questions posed in the Budget Message for the Budget Committee, most of them are really questions that the City Council answers not the Budget Committee. Interim City Manager Allen discussed the difficulties in implementing a business license. There was also a discussion on the lift station that needs to be replaced for transferring sewage water.
