3. Pledge of Allegiance

Mayor Mulenex led the Pledge of Allegiance.

4. <u>Goal Setting for 2016-2017</u>

Mayor Mulenex stated that before school is out there will be a mural on the back of the building of Harvest Depot. He said this project was a result of a grant from the Oregon Arts Commission and is an example of the Arts program at work in the City of La Pine. He said the City will contribute something to the project which the City has already budgeted. Councilor Agan discussed the landscaping rocks that are labelled and used by some cities. Mr. Allen said they are waiting for the branding process to be complete. She also commented on the sidewalk at City Hall having some cracks in it and in need of repair. Mayor Mulenex mentioned the deicer material and how it can damage the sidewalk. Councilor Scott said he would like to see more maintenance on the blacktop pathways on Huntington. Mayor Mulenex discussed having a rule that the people who own the property take care of the sidewalks. Councilor Ward discussed the ice that is left after

clearing off the snow. Mr. Allen said there is an ordinance in draft form requiring property owners to keep their sidewalks cleared of snow. He said it is difficult to enforce on vacant land.

Councilor Scott discussed more grading for the Cagle neighborhood. Mr. Allen said they are planning on doing grading every two months in the Cagle neighborhood. Councilor Ward said she would like to see some trash receptacles around town, especially around McDonalds. Mr. Allen said they are looking into placing trash receptacles in the City. Councilor Ward mentioned the hazard created with drivers parked alongside the streets waiting for the school bus. Mayor Mulenex discussed clearing a larger right-of-way area on those roads to make room for the cars. Mr. Allen said when the water and sewer go in for the Cagle neighborhood the roads could be widened at that time.

Councilor Martinez stated he liked the idea of having a monument with landscaping for a flag pole by City Hall. Mr. Allen said over the next couple of years one could be done at 1st Street and another one done at Wickiup Junction. He also said this is something that the college students from the Sustainable Cities Program could do as part of their projects with the City. The program would cost about \$30,000 with the City paying for about half of it.

Councilor Scott left the meeting at 4 pm due to scheduling conflicts.

Councilor Martinez mentioned that all employees need identification cards. Mayor Mulenex said that the Shine on La Pine organization will join forces with the City on Clean-Up Day. He also said he would like a full picture of the TRT (Transient Room Tax) fund. Mr. Allen said the revenue would go up as motel rates go up.

5. City Manager Transition Plan

Mr. Misley stated that the Council members, he and Mr. Allen had already met with were in favor of a transition period of about six months. Up until that date things will stay about the same as he continues to take on more responsibilities. On July 1, 2016 there would be a formal transition but Mr. Allen will still be involved in managing the City. This would be especially true regarding managing the leases in the Industrial Park. Mr. Allen said he would still be handling a lot of phone calls regarding leases. He said they are also increasing the budget for the City Planner because of increased needs. Mr. Allen said that staff is maxed out on projects and other things. Ms. Williams discussed the properties that are not currently hooked up to sewer and water. Mr. Allen said they will assist these homeowner's in paying for the cost of hooking up to the services by maybe giving them monthly payment arrangements. Mr. Misley said the City has received a number of applications for development in the recent months. Councilor Agan said she was pleased that Mr. Allen will still be involved in managing the City in certain areas. She also said she had full confidence in Mr. Misley. Councilor Ward said she has seen Mr. Misley grow in his position and she is glad Mr. Allen will still be involved to a certain extent.

6 Public Comments

Gloria Fleming stated that it would be nice to have a bulletin listing all the projects that the City is involved with at this point in time. She also suggested getting some high school students in to help with some of the project work. Jim Fleming discussed the building mural in Bend and how it related to the sign ordinance. He also suggested to have a locking mechanism to prevent theft of the flag. Mr. Fleming said when he worked for a public entity every employee had an I.D. badge.
