6. Public Comments

Bob Denend, Board of Directors for the La Pine Rural Fire District, stated he wanted to discuss the beautification and landscaping of the swale and the surrounding area in front of Fire Station 101. He discussed the letter they received from Deschutes County. It stated that they have been in contact with Little River Landscaping to design a green concept. The land is owned by the County with an easement. The plan does not include an irrigation system. Little River will provide maintenance for two years for the landscaping. Mayor Mulenex suggested that this matter be saved for a Work Session so the Council could review the details and move forward if they so desired.

7. Request for City to Fund 10% of the Business Retention & Expansion Program

Ann Gawith, Director of La Pine Chamber, and Dan Varcoe who was with RDI (Rural Development Initiative) spoke to the Council. Ms. Gawith discussed the program that supports the businesses in the community and also has the resources provided by RDI to the businesses. Mr. Varcoe said it would cover business retention and expansion. He said businesses have invested in the community. He said that RDI will fund part of the program to enhance businesses in La Pine. They are asking for a donation from the City for the program. He said the program will be from 1 to 2 years. Mr. Varcoe said the USDA (United States Department of Agriculture) will fund 90% of the program. He said they are asking the City for \$2,500 for their portion. Mr. Varcoe said it will be a \$25,000 program. He said RDI will also be looking for funding for this program. The Chamber will manage the program after the training of volunteers who will assist the businesses. Mr. Misley said that, in the budget, there are monies to assist businesses in La Pine. Mayor Mulenex said he would like the Chamber to come to a meeting and let the City know how the money was spent.

A motion was made by Councilor Scott and seconded by Councilor Martinez to approve the Grant as Requested for the Funding as described by the City Manager and that they come back to the Council with a report as to how the money was spent.

Mr. Misley said this ordinance was in regard to the increase in planning applications. He said there is more happening with public improvements. Eric Huffman, City Engineer, stated that there are two standards. He said the design standard is related to the infrastructure that goes in from a developer as well as design standards for the City. Mr. Huffman said a bond will be required from the developer and also they will need to meet with the City to construct public improvements to meet City standards. Councilor Scott said that this is a good thing and is really needed. The Council had consensus that the standards were really necessary.

12. Update on Mural Grant through Arts Central

Mr. Misley stated that Deborah Allen who is the Interim Director of Arts Central, said Arts Central is no longer an entity, it is dissolved. Mr. Misley said the City had given \$4500.00 to Arts Central. The mural project will not be happening, now. Mr. Misley said the City needs to have the money refunded. He said the City attorney and the media will assist in getting the money back. The Council decided not to use the media for getting the money back.

13. Other Matters: Only those matters properly added to this Agenda under line item No. 4

Light on SLED (Sunriver La Pine Economic Development. Mr. Misley said that Janice Burton is resigning on November 11th as the Economic Development Manager. He said the position is funded half time. Mr. Misley stated that Ms. Burton found herself working more than half time. The recommendation was to move the position to three quarter time. Mr. Misley said the City would need to contribute \$5,000 additional monies to cover the extra hours for the position. The remaining monies needed would come from a couple of different sources, the County and private sources. Councilor Martinez said he did not agree with the new name for the organization. Mayor Mulenex said he also did not agree with the name and the City should have gotten some say in it. Mr. Misley said he will pass this matter onto the SLED Board. He also said he believes the position should go to full time but it would have to be budgeted for by the City.

14. Public Comments

Don Greiner discussed the letter he sent to the Council regarding an area that needs attention. That property is considered a hazard to Crescent Creek. He said it appears that young people are smoking cigarettes in that dry timber area. Mr. Misley stated that he told Mr. Greiner that he would review ordinances to see what responsibility the City has and also he asked that Mr. Greiner contact the Fire Department to see if they had a program to resolve the problem. Mayor Mulenex said that he does not believe that the City should be responsible for a private organization's problem. Councilor Scott stated that many properties in La Pine have that same problem.

15. Staff Comments

Mr. Misley said on November 16th the FCS group, who are working on the revised SDCs (System Development Charges) will be coming to the City for that Work Session. He also discussed changing the date of the September Work Session to September 27th at 2:00 pm. This change is due to the League of Oregon Cities Conference that week. Mr. Misley said that he will be meeting with a landscape architect about a monument or welcome sign. He said the new website is being developed. Mr. Misley discussed the affordable housing tour and the three councilors that were able to attend. He said they have been having meetings with COIC (Central Oregon Intergovernmental Council) and ODOT (Oregon Department of Transportation) regarding the 4th Street project. He said he should have an update for the Council at the Work Session.

16. Council and Mayor's Comments

Councilor Agan said she was really impressed with the homes that were on the tour of affordable housing. She said the swale at the light should be low maintenance and attractive.

Mayor Mulenex said he went to the Air Show in Madras. He discussed the swales that were in that City. Mayor Mulenex said they were made to be attractive. Councilor Scott said there should be standards for swales in the City. Councilor Martinez said the City still needs a flag pole. Mr. Misley said that could be part of the monument project.
