1. Call to Order

The Pledge of Allegiance was led by Student Councilor Treydon Plamondon.

3. Changes to Water and Sewer System Development Charges – FCS

John Ghilarducci from FCS gave a presentation on the proposed changes to the SDC's (System Development Charges). Mr. Misley said he has worked with John to come up with the amounts for the proposed changes. Mr. Ghilarducci stated that they calculate an SDC based on the cost of capital projects and infrastructure that has already been built. SDC's will, generally, just be charged for development of properties not existing developments. The State of Oregon also has regulations governing SDC's. The SDC should represent one share of system capacity needed to serve the new development. There are two fees, one is the improvement fee and one is the reimbursement fee. The wastewater system charges are more than the water system charges. The wastewater improvement project list total is about 14.3 million and about 6.25 million in expected grants. Much of this would benefit the expansion of services to Cagle and Glenwood neighborhoods. For meter charges that are larger, the rates would go up by flow capacity of the meter. Mr. Ghilarducci said they expect 4.35 million in grants for the water improvement fees. He said the law requires that a public hearing, regarding the changes, must be noticed 90 days before the hearing. Jake Obrist said going to the meter size for establishing SDC's is the best method, in his opinion.

Karna Gustafson from Central Oregon Builders Association (COBA) stated that a builder in La Pine has spoken with her and discussed the need to phase in the new SDC's. She said they already have the project costs in place and the new SDC could create a real hardship for them. Ms. Gustafson said it could really affect the pricing for construction projects or a contractor may decide not to build the project. Councilor Martinez discussed the need for raising the rates because of the

increased cost of services that are provided. The Council concurred with the need to increase the rates. They also suggested delaying the changes to the SDC in the current year and not as early as January 2017. There was also a discussion on doing community outreach regarding the change in the SDC.

4. Housing Works Planning Applications - Comprehensive Plan Map Amendment and Zone Change

Mr. Misley discussed the Housing Works application for a map amendment and zone change. He said an Ordinance would come before Council on December 14, 2016 at the Council Meeting. Councilor Scott also said that he was at the Hearing on the planning application and it was a very thorough presentation.

5. Discussion on Land Use Planning Services Agreement

Mr. Misley said that the contract with City Planner, Tammy Wisco, will expire on December 31, 2016. He said she would like to continue working with the City. Mr. Misley said that Ms. Wisco would like to make some changes to a new contract. There was a discussion on moving the planning contract decision into January but then it was decided to have it on the agenda for December.

6. Public Comment.

Rex Lesueur, area resident, discussed the sidewalk ordinance. He said the sidewalks around his building belong to the County. Mr. Lesueur said he would have to maintain someone else's sidewalks. He said this ordinance is out of line for this community and creates a real hardship for business owners. He said he would like the City to revise the ordinance and make it more fair.

7. Removing Bills and Invoices from Consent Agenda.

Ashley Williams, Accounting Clerk, stated that Councilor Martinez was unable to vote on anything on the Consent Agenda because he had to recuse himself because of the Wilderness Garbage bill. She said this is why bills and invoice have been removed from the Consent Agenda. Councilor Scott said it already takes two Councilors to sign the checks and that process provides a review of the bills and invoices.

Councilor Martinez opened the Public Hearing.

b. Staff Report

Mr. Misley stated this ordinance concerns snow and ice removal in the City of La Pine. It prohibits parking along City streets for snow removal. Mr. Misley said that there is currently an ordinance that states that vehicles cannot park in the right of way. He said narrow roads do not allow the snow to be pushed over to the side by the snow plows. Mr. Misley said that the ordinance says no parking will be allowed in right of way when there is four inches or more of snow. Public outreach will be done. He also said that signs regarding the parking restrictions would be put in place on the City roads. Councilor Martinez said the snow plowing of the roads is important for citizens to get out of their homes.

c. Public Comment

Gary Gordon, Director of the Board of Directors for the La Pine Park and Rec District, said he thought the sidewalk ordinance needed to be reviewed by the Council and changes made to it. He said the time period to have it cleared off was too short during the winter months. Rex Lesueur discussed the fact that cars parked on the street will have a huge brume of snow around them when the road is plowed.

9. Resolution No. 2016-19 A Resolution Amending City of La Pine Resolution No. 2016-10, Which Resolution Established Certain Sewer Rates, Charges, and Fees Effective as of July 1, 2016, To Increase City's Outside Sewage Charges Effective as of December 1, 2016.

Jake Obrist said that there will be certain rates for septage companies depending on if they are in the Sunriver/La Pine area or from other cities like Bend. He said the rates are also being raised because currently the rates are low so it encourage more dumping and that is not good for the septage system. The new rates are lower for the Sunriver/La Pine companies.

11. COIC Comprehensive Economic Development Strategy

Mr. Misley said COIC represents all the counties and cities within Central Oregon. He said they help with economic development. Mr. Misley discussed that there is a demand for space in the Industrial Park even though there are few buildings and that needs to change. He said he would also put into the strategy a streetscape for the east side of Highway 97. There was also a discussion on having a meeting, facilitated by COIC, with the Park & Rec District and other entities to review long term projects and strategies in the City of La Pine. Councilor Scott stated that he attends the COIC meetings and sends e-mails out to the Council regarding the items discussed at these meetings.

12. Code Enforcement Update

Mr. Misley stated that he has been documenting various code violations in the City. He said he has been writing to owners of those properties regarding the code violation(s) on their property. Several of them involved trailers that people were living in on the property. Mr. Misley said all the Public Works Pick-ups now have cameras for staff to record code violations that they may see around town.

14. Public Comments

Rex Lesueur discussed the sidewalk snow removal ordinance. City Manager Misley stated that he did not see an issue with an ATV removing snow from sidewalks and temporarily being on County roads. He said if there is an issue it could be brought to the City Council.

Councilor Ward stated there may be a problem at the Senior Center with the sidewalks getting cracked while the snow is being removed off of them.

15. Staff Comments

Mr. Misley discussed the request for a donation_for the Honor Guard of the American Legion for \$80.00 and that it was on the Consent Agenda. He said it was to place flags on the graves at the La Pine Cemetery. Mr. Misley said they have interviewed candidates for the EDCO Manager for SLED (Sunriver / La Pine Economic Development). He also said the position has been increased from half time to three quarter time. Mr. Misley said that documents on the water/wastewater expansion are available for the public to obtain at City Hall. He also said there would only be one Council Meeting in December, it will be a combined Work Session and Regular Session and will be held on December 14, 2016.

16. Council and Mayor's Comments

Councilor Scott stated that there needs to be a discussion on what the City can do to honor the people leaving the City government. He also said that Ordinances are not for the Council. They come about from the public coming to the City with an issue. Councilor Scott said he did not see any problems with using an ATV to clear off sidewalks from the snow.

Student Councilor Treydon Plamondon stated he was a senior in High School. He said he just finished soccer and also does track. Treydon said he has been involved in student government.

Councilor Martinez said they recommended two candidates to be interviewed by EDCO (Economic Development of Central Oregon) for the open manager position. He said on December 17th "Wreaths Across America" will held at the Senior Center.
