C. Work Session - Following Special Session

Mayor Scott called the meeting to order.

1. Discussion on Regional Organizations with City Representatives

The Mayor and Councilors discussed the various organizations in Central Oregon and which ones they would like to represent the City.

Mayor Scott said he would like to be the primary representative for the COACT meetings. Mr. Misley stated that this group is the Central Oregon organization for all transportation. COIC is the policy board that covers the transit provider for Central Oregon and work force training. COCO is the Central Oregon Cities organization to represent Central Oregon cities in State legislative matters. SLED is the Sunriver La Pine Economic Development and is the organization to bring economic development into the Sunriver and La Pine areas. Mr. Misley said the Small Cities Network is part of the League of Oregon Cities that lobbies on behalf of the small cities in the entire State. There was also a discussion that there is a reimbursement for mileage.

Mayor Scott said he wanted to be the primary representative for COCO because all the Mayors go to it. Councilor Martinez said he would like to be the primary representative for SLED. Councilor Ward said she would like to be the secondary for SLED. Councilor Greiner stated he would like to be the representative for the Small Cities Network. Councilor Briese stated that she would like to be the secondary for the Small Cities Network. Councilor Briese said she would like to be the representative for COIC and Councilor Greiner would be the secondary. Councilor Martinez said he would be the secondary representative for COCO. Councilor Briese said she would be the secondary representative for COACT.

Councilor Greiner recommend that Councilor Martinez be the Council President and Councilor Ward agreed with it. Council had consensus for Councilor Martinez to be the Council President.

2. Discussion on City Charter and Council Rules and Procedures

Mr. Misley said the Charter is like the constitution for the City. Councilor Greiner said the incorrect address of City Hall was in the Charter. It had the old address. Councilor Greiner discussed the schedule for Councilors to place something on the agenda. He also discussed the time schedule for having the agenda packet available for the Councilors. Mr. Misley said the staff's goal is to have the agenda packet ready by 5 pm on the Thursday before the meeting. Councilor Greiner said any request for money from the City should go on a Work Session before it goes to the Council Meeting. Mr. Misley discussed the restricted and non restricted funds. Councilor Greiner discussed establishing the quorum. It was stated that each Councilor needs to acknowledge their presence at council meetings. Councilor Greiner asked for clarification on the emergency clause in some of the ordinances. Mr. Misley said that puts the ordinance in effect immediately. It was discussed to have the topic of the emergency clause on ordinances on the agenda for a future Work Session. Many of the ordinances reference the emergency clause in them. Councilor Martinez said the public does not understand the emergency clause in an ordinance. Non-emergency ordinances will go into effect after 30 days, once they are passed.

Mr. Misley stated he has planned a joint meeting with the Board of County Commissioners and the City Council on February 8, 2017.

3. Discussion on Proclamation for Designating the Month of January as National Mentoring Month

Mr. Misley said this was brought before the City Council in a Work Session prior to it going on the Council Meeting Agenda. This was done to see if the City Council wanted a proclamation on a particular item. Councilor Martinez stated he would have liked more of a description than this proclamation request form provided. The Council had consensus to have this Proclamation on the agenda for the January 11, 2017 Council Meeting.

4. Public Comments

Mrs. Scott said the Proclamations make the City look good as well as being supportive of the Proclamation.

5. Staff Comments

Mr. Misley announced that there would be a work session with a regular session to immediately follow it, at both the January 11, 2017 meeting and the January 25, 2017 meeting. The Council had consensus for the meetings to start at 5:30 pm. Councilor Martinez mentioned he would like to see some daytime meetings.

6. Council Comments

Councilor Ward welcomed the new Councilors and Mayor. Councilor Briese said she was looking forward to serving on the Council.

7. Mayor's Comments

Mayor Scott discussed the Facebook page regarding the City of La Pine. He said he will be posting issues important to La Pine residents on it.

Councilor Briese discussed the warming station that is being held at the Calvary Chapel for the next month. It will also be opened at zero degrees. She said they can also house animals. It will be opened 6 am to 7 pm for arrivals.

Mayor Scott stated that he would like verbal reports when the Councilors attend various community meetings. He said under Council Comments that would be a good opportunity for Councilors to ask staff at that time.
