6. Public Comments

Commissioner Doug Ward said that Ginny Woodruff, who is seeking appointment to the Planning Commission, was not able to be here tonight as she was out of town.

12. Proclamation renaming Highway 97 through La Pine to Ashton Eaton Boulevard and declaring the week commencing November 11, in Ashton Eaton's honor.

This item was moved forward in the agenda.

City Manager Hasson discussed the renaming of Hwy 97 through the five miles of the City. He said that all the agencies that have an interest in the naming process have lent their consent to this request. City Manager Hasson said a proclamation has been done in recognition of Ashton Eaton's accomplishments. Roslyn Eaton (Ashton's mother) and Carolyn Wallace (Ashton's grandmother) were in attendance. Ms. Eaton discussed how excited the family was for this honor.

7. La Pine Rodeo request for public monies in the sum of \$3,000 to assist them sponsor the 2013 rodeo event.

Gina Wearin, Vice-President of the Rodeo Association gave a presentation about the rodeo. She discussed the recent BLM land transfer that will give the rodeo a new and permanent home. Ms. Wearin said for the 2013 rodeo schedule there will be a three day event instead of the two day event.

She also discussed the benefits with a \$3,000.00 sponsorship such as V.I.P. tickets. Ms. Wearin said that the La Pine Rodeo is the only rodeo in Central Oregon over the 4th of July. She said for 2012 the rodeo attendance was 2,154 people.

City Manager Hasson stated that when organizations ask for money they now fill out a form and it is reviewed with the City's budget. He said the City had put \$600 in the budget for a rodeo donation. However, he said that the City recognizes how important the rodeo is for the City. City Manager Hasson also said that the Visitor's Center was asked by the City to provide some funding for the rodeo.

Councilor Varcoe stated there was a possible conflict of interest due to the fact that he owns the land that the rodeo currently uses for their event. There was a discussion of meeting the rodeo's needs by

monies coming from both the City and the Visitor Center's dispersal of TRT (Transient Room Tax) funds.

Councilor Agan made a motion to give \$600 to the Rodeo Association. Motion died for lack of a second.

A motion was made by Councilor Agan and seconded by Councilor Greiner to approve giving \$1,500 to the Rodeo Association.

8. Current budget – new format

City Manager Hasson stated the new financial's format has four columns. Column A shows how much money has been spent in a month. Column B keeps a running tally of what has been spent to date. In column C is the annual budget, the total amount of monies allocated for that particular line item and column D is the budget percentage to date. It was decided that it would be easier to total the first page and then total the second page because of the fact that water and sewer revenues are restricted. Mayor Mulenex said he would prefer budget sheets that show line item by line item. Finance Officer Martin said she can run other reports once she gets the full budget into the new accounting software program. Mayor Mulenex recommended a quarterly review of the budget and expenditures by the Council and staff.

9. Reappointment of La Pine Public Works Advisory Committee members for specific terms of office as identified in City of La Pine Resolution Number 2011-13. The initial timeframes established were not followed so the Committee has taken action to correct this oversight.

City Manager Hasson stated that when the committee was formed it was understood that some members would serve until the end of the year and some would be for an additional year. He said nothing was done to adjust the terms. He said they are now asking for the Council to appoint the committee membership for the time period stated.

13. TRT audit review findings. The City contracted with Pauly, Rogers and Co., P.C. to review five of the six establishments that provide the City with TRT revenues to assure they practice appropriate accounting procedures. (Rosland was not reviewed because of seasonal operations.)

City Manager Hasson stated that this is a process to avoid having to take action against a business because they have not reported and paid for their TRT (Transient Room Tax) revenues correctly. He said after review there was very little discrepancy in the actual versus the reported revenues. The Council had consensus for a letter to be sent to the one business entity that had a small discrepancy.

City Manager Hasson discussed the STIP (Statewide Transportation Improvement Plan) grant monies that the City is applying for at this time. He said the monies would be used for sidewalks and also something to help with pedestrians crossing Hwy 97 with some kind of established pedestrian crosswalk. He said there will probably be about a million dollars of grant monies for the City if awarded the funds.
