5. Interviews for Urban Renewal Agency Board Vacancy

Russ Smith

Russ said that his interest in Urban Renewal is because it is one of the things that he is less involved in with the City. Russ said that he hasn't looked at the goals for the Urban Renewal Agency. Russ said that he would like to see sidewalks from the Prairie House to the rest of the City. Russ said that he would include local businesses on Urban Renewal by going out and talking to them about what they envision. If it came between an infrastructure or a business Russ said that he would chose the infrastructure because that is what brings the businesses in. He is in favor of making La Pine look more presentable. Russ said that his vision of an Urban Renewal District is actually building the urban part of the City, not renewing it because we are such a young city that it has not been made urban yet. Russ said that his vision for the town would not be strictly regimented, but he would like to see it more uniform. The question was raised if there could be enough separation between the committees Russ already serves on, and Russ said that he could handle that. Russ said that getting the children more involved in the Urban Renewal set up would be beneficial. He believes that getting the kids involved in a tech program would be good.

Andrea Hine

Andrea said that her key word would be "communication." She felt that the best asset would be listening and recommending things based on what people would want. She said that she is really passionate about La Pine because the spirit in this town in very tangible. She said that she would be really happy explaining what is involved and engaging the public. She said that she would like to help continue with what other people have already started. She said that she thought the goals seemed to be exactly in line with what the city is doing. She said that she didn't feel that one goal was better than the other. She stated that not involving the City's youth will make the plan lack longevity because they will be the majority of the future. Andrea said that her job would be to work on communication. She said that she doesn't think that anyone should join a group if they can't live with the decisions they make.
