## ii. Staff Comments

Interim Director Rick Allen stated that these loans are the ones outstanding in the Water District. He said they hired Orrick who was the bond counsel. He said it states that the City will assume responsibility for the debts and get them paid back to USDA (United States Department of Agriculture). He said this is not an emergency clause ordinance; it will not take place for thirty days.

Ted Scholer, area resident, stated that Director Allen had answered his question about the assets as well as the debts.

#### v. Council Deliberations

In response to a question from Councilor Varcoe, Director Allen said that the loan is what it is and it is necessary to assume the loan in order to withdraw the Water District. Councilor Varcoe mentioned the balance in February was \$2,391,693 on one bond and the other bond was approximately \$289,000.

## 8. La Pine Senior Center Request for Matching Funds Grant

Councilor Greiner stated that he believed he had a conflict of interest with this item. Mayor Mulenex said that the request is to resolve an issue with the gas that backs up in the building. Councilor Agan said her understanding was to keep the Senior Center open this repair was a necessity. Councilor Greiner said during the past six years there have been a lot of problems with the way the building was constructed. He said it is a sewer situation. Councilor Greiner said that the way the building was plumbed was to have all the grease that goes through the dishwasher and everything in the kitchen into the main sewer line. He said once the hot grease goes through the line and gets to the outside of the building and clogs up that line and then the sewer backs up into the bathrooms and various rooms in the Senior Center. Councilor Greiner said they have raised about half of the money for the work to be done. He said they will cut the line to the grease trap and send all of the effluent from the kitchen that has any grease in it to the grease trap instead of clogging a sewer line. Councilor Greiner said they will also need to clean out the old line

that runs through the sewer right now because it probably is plugged up. Councilor Martinez asked about the local businesses that had given a pledge. Councilor Greiner said that a business had pledged an amount of \$500. Mayor Mulenex said this is an opportunity for the City to assist an important entity in the community. Councilor Greiner stated that there has been no public assistance for the Senior Center. He said they have just completed maintenance and renovation on the building for \$30,000. Those monies were raised by the Senior Center and their volunteers. Councilor Greiner stated that they were confident they can get the needed work done for no more than \$4,000.00.

Councilor Agan made the motion to consider the \$2,000 donation for the Senior Center repairs. Motion died for lack of a second.

# 9. Request from La Pine Frontier Days Association for Donation

Ann Gawith, President of the La Pine Frontier Days Association gave an overview of her request. She said that Frontier Days needs more sustainable funding. She said that a lot of the larger sponsors have either closed down or moved out of town or are unable to contribute to it this year. Ms. Gawith said that the program, which the donation would fund, is a very important part of Frontier Days.

Councilor Varcoe stated that this event is an outstanding event and he believed that the City should donate the monies requested. Ms. Gawith said that the TRT (Transient Room Taxes) funds are only for marketing outside of a fifty mile radius from La Pine.

# 12. Public Comments

Vicky Jackson, area resident, asked about the grease traps and local restaurants. City Manager Hasson said that there are a number of commercial ventures that need to pre-treat before they discharge into the sewer system. He said the City will be ever so diligent to make sure that any kind of business enterprise that comes in is evaluated to ensure that nothing will be going into the sewer system that is not allowed. Councilor Greiner stated that there is a large underground trap and as the grease goes in there it settles at the top and the liquid goes out underneath and then to the sewer system or septic system. (So all the liquid that is not grease goes into the systems.)

Ms. Jackson asked about TRT funds that the City maintains. Mayor Mulenex said that 70% of the TRT funds go to the Visitor's Center to be disbursed and 30% goes to the City. City Manager Hasson said that there needs to be adequate reporting and oversight regarding the funds that are given to the Visitor's Center. He said the City is currently exploring this need.

## 13. Committee Reports

Councilor Greiner stated that he attended the COIC (Central Oregon Intergovernmental Council) meeting. He said they are looking for a manner of funding Cascade East Transit. Councilor Greiner said that they would like some type of permanent funding. He said they would like the City to tell them what type of funding they would like to see. Options are a property tax increase, payroll tax, levy of dues, local gas tax, utility fee, local sales tax or just an increase in fares.

Mayor Mulenex discussed the Oregon Transportation Commission meeting that he and the City Manager recently attended. He said it was an extremely valuable opportunity to have them come over to this area and hold their meeting. Mayor Mulenex said that they had a session where they talked about Central Oregon and some of the complicated aspects of transportation and current limitations in the law as it relates to permitting certain kinds of road construction and access. He said that they discussed things that would really be helpful for Central Oregon but that are currently hampered by some of the State statues. Mayor Mulenex said they understand that this needs to be corrected and they are working on it. He said he was very pleased with their impression of La Pine and also where they see their ability to help La Pine in the future.

## 14. Staff Comments

City Manager Hasson stated that a team from the State of Oregon, representing various agencies, will be coming to the City of La Pine on June 7<sup>th</sup> at City Hall. The meeting will start at 11 am and go to 2 pm.

Interim Public Works Director Rick Allen stated that for the USDA loan transfer they want to make sure the City meets all the ADA (Americans with Disability Act) requirements. He said he is also looking into

getting a phone for the hearing impaired. Director Allen said that they needed an ADA Coordinator and he recommended City Manager Hasson perform that role.
