7. Ordinance No. 2012-02

An Ordinance adopting the City of La Pine's Comprehensive Plan, Chapter 5, Historic Areas and Historic and Cultural Resources

City Manager Hasson stated that he had some concerns about the Ordinances after briefly looking at them and would like more time to review them. He said they could go ahead and have Public comments at this time but table the approval of the two Ordinances to another meeting. City Manager Hasson stated that private property rights need to be protected and that is one issue he has with the Ordinances. He also said no one should be going onto private property without consent. Mayor Mulenex said he also had some reservations with the Ordinances as they are currently written.

a. Open Public Hearing

Mayor Mulenex opened the Public Hearing.

b. Staff Report

Deborah McMahon from DMC Inc., stated that from the comprehensive plan, goal five requires that they look at historical resources. After the comprehensive plan was reviewed the State told them they needed to add to goal five.

Pat Kliewer, from Kliewer Engineering Associates, stated she has been a planner since 1989. She said back in 2008 she wrote a grant to allow her to spend a year inventorying every property in La Pine that had a building 40 years old or older. She stated in Oregon each jurisdiction is required to inventory their historic structures every 10 years and they consider any structure over 50 years to be a historic structure.

Ms. Kliewer said that the State requires that, with property owner's permission, the City Council has the authority to designate a particular property within its City limits as a historic resource. The state requires a City to protect any property that is on the National Registry. She said there are no properties in La Pine that are on the National Registry. Ms. Kliewer said the only entities that have a historic rating are the Cemetery and the Grange.

Ms. Kliewer stated that they put in a ten day advance notice for the Landmark's Commission to go on someone's property. She said that the Oregon State law states that no property can be designated as an historic building without the homeowner's permission. Ms. Kliewer said the State wide planning goal spells out that City's and County's should provide for historic planning as well. She said the State tells the public entity how often they have to inventory their historic buildings.

Councilor Varcoe asked about historic districts. Ms. Kliewer said there are no historic districts in La Pine. She said it can only be created by the National Parks or the City Council.

In response to a question from Mayor Mulenex, Ms. Kliewer said if there is a problem getting people to serve on the Landmark's Commission the Planning Commission may serve as the Landmark's Commission. She said they want to ask the State to certify the City as a certified local government and show them that the historic preservation code is qualified and should receive funds. Director Allen said the Landmark's Commission would meet on the same night as the Planning Commission if the Planning Commission takes over the role of the Landmark's Commission.

Ms. Kliewer stated that there is no fee charged for an application to designate a historical or cultural resource. She also said the Landmark's Commission will rarely have an application come before them. And, it only needs to meet quarterly. Ms. Kliewer said also that the State provides training for the Commission.

Councilor Greiner asked if this Ordinance was something that had to be passed tonight because he would like to give the City Manager time to review the Ordinance and give his opinion. Councilor Martinez said he agreed with Councilor Greiner. Councilor Varcoe stated he liked the summary of La Pine's history that was done. He said there was a resolution done by the County regarding the name of La Pine and having a space between La and Pine.

John Thomas, Vice Chair of the Planning Commission, stated that there has been a lot of work that went into the Ordinance. He said that the City Manager definitely needs to approve of it as does the City Councilors.

8. Ordinance No. 2012-03

An Ordinance adopting the City of La Pine's Code Section 20A., Historical and Cultural Preservation Program and the La Pine Landmarks Commission.

a. Open Public Hearing

Mayor Mulenex opened the Public Hearing.

b. Staff Report

Pat Kliewer stated that the code only applies to the cemetary and the Grange, the only classified historical structures in La Pine at this point in time. She said this code does not go inside any buildings. Ms. Kliewer said that the interior of the buildings are not subject to any kind of approval by the City Council. She then discussed the ten day notice for inspection of a structure that may have historical significance. Ms. Kliewer said any application that would come before the Council would have to be signed by the owner of the property, first.

Deborah McMahon stated that section 20A of the code, would be inserted into the zoning ordinance. It would be the regulation that helps regulate historic structures. Pat Kliewer stated that the document is very comprehensive and will be good for a long time into the future.

11. Further Discussion and Possible Action for a High School Student to sit on the City Council

City Manager Hasson discussed the memo he wrote regarding the matter. He said he did research on different approaches to the issue. City Manager Hasson said he met with the Principal and Athletic Director at La Pine High School. He said that the High School has a leadership program and suggested this topic ought to be a topic for the next term and let the students come up with the idea of what type of connection they would like to have with the Council. He said there are a number of positive things that can come about through having a high school student on the Council.

Councilor Varcoe stated he liked the approach to the matter by letting the students come up with the idea and bring it back to us. The Council had consensus to leave it to the City Manager to proceed with the school staff. The Mayor said he would like to be involved with it.

12. Approval of Contract to Purchase Casselle Accounting Software

Director Allen stated that they incorporated one more year of history for the utilities per a request from the Council. He said the Council already approved the City to enter into a contract with Casselle but had not yet approved of the contract.

13. Appoint Budget Officer, Review Budget Calendar and Appoint Budget Committee Members

City Manager Hasson stated that he and City Recorder/Finance Officer Lori Martin spent a day in Eugene attending a workshop with the Department of Revenue so they could understand the budget process in Oregon. He said that there was a new bill passed by the House that made some changes to the budget

process. City Manager Hasson discussed the budget calendar he had prepared. He said the budget process needs to go before the Budget Committee with the first meeting scheduled for the March 28th at the City Council Work Session. City Manager Hasson said that tonight the Council needs to appoint the Budget Officer. He recommended City Recorder/Finance Officer Lori Martin be appointed to be the Budget Officer. City Manager Hasson said the Council also needs to appoint the members of the Budget Committee. He said that three members of the Budget Committee members are from last year and will serve on the Committee for this year. City Manager Hasson said that he had three applicants for the remaining two spots on the Committee. He also discussed term limits as the State Statutes call for staggered terms of office for each of the Budget Committee members.

14. Other Matters

14a) If I Were Mayor – Ken Mulenex

Mayor Mulenex stated that annually there is a program called, "If I Were Mayor." He said the cities go out and hold a contest with three age groups and they have a theme. Mayor Mulenex said these young people put together a presentation based on that theme. He said at the Annual Mayor's Conference is when they do the awards. Mayor Mulenex said the schools select the best presentation and the winner represents the City. He said some cities give money to the winners. Mayor Mulenex said he would like

to see La Pine award \$100 to each of the winners in the three categories. He said he would be going around to the schools to implement the program.

Councilor Varcoe stated he was concerned that the process is starting late and would need to be completed by the middle of April. Councilor Martinez also mentioned his concern about starting this program late. Mayor Mulenex said that he is confident that there is enough time to implement the program and also have winners. He said he would like the Council to approve the \$300 that would be spent and that he would come back to the next Council meeting and do a presentation on the progress with the schools. Mayor Mulenex said he would not be offended if the Council thinks they should wait a year to do the program.

Kathy Stagland stated that they have problems with the speed on Huntington Road in front of their shop. She said students are crossing a lot between the post office and the strip mall. Ms. Stagland said there needs to be crosswalk from St. Vincent's to Bi-Mart. She said she thinks the speed limit should be lowered to 25 mph. City Manager Hasson said he will make arrangements to come out and take a look at it.

City Manager Hasson stated that it is important to have another member on the Council. He said he would appreciate if a closure date could be made on the announcement for a City Council member. City Manager Hasson said he felt it was important to get the position filled.

Director Allen stated that next Wednesday, March 21st, there will be a meeting for the Withdrawal of the Water and Sewer Districts at 5 pm. The Hearing was held on March 7th. He also said that he talked to Newton Consulting to handle the transfer of water rights and asked them to start working on it. Director Allen said the water rights need to be in the City's name. He said the Public Works Committee met and it was a very successful meeting with someone from the Road Department for Deschutes County speaking. Director Allen said that the paved roads in the City of La Pine are supposed to be surveyed by the County regarding the condition of the roads. He said he has contacted the County about doing the survey.

City Manager Hasson stated that the Public Works Committee meeting was very successful. He said magnesium chloride helps eliminate dust on roads as well as helps to hold the road together. City Manager Hasson said he would like to get a cost of how much it would be per mile. He said eventually they will craft an Operational Manual stating 'here's how the road system works from a to z.' City Manager Hasson also said there will be a number of questions that come to the Council for policy decisions. Director Allen said that a representative from ODOT (Oregon Dept of Transportation) will be at the next meeting of the Public Works Committee.
