Resolution No. 2014-04 A Resolution Authorizing a Change of Bank Accounts at Washington Federal Bank, Closing Bank Accounts at Home Federal Bank, Opening a Bank Account at US Bank, both located in the City of La Pine, Oregon, Designating both as Depositories for Funds of the City of La Pine, and authorizing signatories on Bank Accounts.

Summer Sears, Financial Consultant for the City of La Pine, said one of the tasks she had been requested to do was looking at the City's bank accounts. She said several accounts were recently combined. Ms. Sears said they wanted to be sure the fund stayed local. She said they also wanted to create some diversity so that not all accounts were at one bank. Ms. Sears said that the two banks in town were asked to give their qualifications, interest rates, etc. She said they decided to keep the primary relationship with Washington Federal. Secondly they decided to close the Home Federal account due to the fact that they are not a local bank. Lastly, they decided to open a bank account at US Bank and keep approximately \$250,000 in it at this time.

## 9. <u>Discussion on Medical Marijuana Dispensaries in La Pine</u>

- Representative Mike McLane – was not in attendance

Interim City Manager Allen said that 48 cities in Oregon have passed a moratorium. 58% of the cities are not doing anything on the issue. About 40 cities are in a pending stance. Mr. Allen said that the moratorium, if approved, would ban the dispensaries for a year. He said that in order to get it approved it must be unanimously agreed to by the Council. Mr. Allen said that there are numerous rules and regulations like where a dispenser can be located, they cannot be located by a school.

### **Public Comments**

Carson Templer, Sunriver resident, said that he currently has a license from the State of Oregon to open a medical marijuana dispensary. He said that he believes it is something that is good for the community. Mr. Templer said it will bring jobs to the community. He also said there is a need for this dispensary in the La Pine area. He said that the business must report to the State about how much income they generate. Mr. Templer said he has procured a building for the business in the Aspen Shopping Mall. He said he is planning on using a local bank, insurance company, etc., for his business. Mr. Templer said that the prescriptions for marijuana can be up to 24 ounces. He said the product would be purchased from people who are growing the marijuana with a medical card. There was also a discussion on the medical marijuana plants that will be for sale. Mr. Templer said the plants cannot be more than one foot tall.

Student Councilor Conrad Parker asked about the potency of the marijuana. He also asked if all the plants have the same potency. Mr. Templer said that the State of Oregon requires them to have the marijuana tested for potency and any contaminants before it is sold. He said that the marijuana would sell from between \$100-\$250 dollars. There was a discussion on the federal government's stand of marijuana being illegal. When asked about the disposal of the by-products that cannot be used, Mr. Templer had no response.

Randy Huff, La Pine area resident, spoke to the Council about his desire to have a medical marijuana dispensary in La Pine. He passed out some paperwork asking people that were in support of the dispensary as well as people that were unsure or against it to sign the paperwork. Mr. Huff said that right now people have to get their marijuana from growers and so it does not get inspected. He said that his dispensary would limit people to how much they could receive at a given time period. Mr. Huff said the nearest dispensary is in Bend and many people in La Pine do not have good transportation to Bend. He said he has obtained an outlet for his business. Councilor Jones cautioned about the City getting overrun by sellers and it being bad for the City as has happened in some cities in California.

Peggy Vowell, area resident, stated she is for medical marijuana. She said no other medications have helped her with pain the way marijuana has done for her.

## A five minute break was taken at this point in the meeting.

### Meeting Resumed at 7:35 pm.

### **Public Comment**

Ellen Currie, reporter for The Eagle newspaper, said that Humboldt, California has had a drug problem for a very long time. She said that during most of that time there were no marijuana dispensaries there. Carson Templer stated that California does not have regulated dispensaries like Oregon does.

Councilor Agan stated that she has concerns about the availability of drugs to young people that might occur with dispensaries. She said she would probably favor a moratorium on the dispensaries. Councilor Ward stated she felt the same way as Councilor Agan. She said the senior population, she has spoken to, are against the dispensaries. Councilor Jones said he was in full support of a moratorium. Councilor Martinez said that there is a facility in Bend and there is a shuttle that travels between Bend and La Pine. He said he did not understand the process of how the system works so would like a one year moratorium to get the facts. Councilor Martinez said he needs to know how to protect his employees (Wilderness Garbage) with the left over parts from the marijuana processing. Interim City Manager Allen stated that the City could put some limits on the dispensaries as other cities in Oregon have done. Mayor Mulenex stated that he was concerned about the darker side of having marijuana sold in the City. He said the City really needs a year to get everything resolved regarding this issue. Councilor Agan stated that because

Bend has a dispensary it helped her make the decision on a moratorium. Conrad Parker discussed his concern with the youth of the City and how they may be effected by the increased availability of marijuana.

There will be a hearing on the moratorium ordinance on April 23<sup>rd</sup> at 6 pm.

Interim City Manager Allen stated that on the USDA loan there was a \$100,000 difference between what the City thought they owed and what actually was owing, in favor of the City. Apparently all the payments were applied to the principle instead of to interest which decreased the amount due by \$100,000. He also said that community groups will be making their requests for funding to the Council at the budget meetings that are scheduled for the end of April. There was also a brief discussion on the street lights, some of them have been put up. Mr. Allen said that the sidewalk project is going out for bid and he has been assured that the project will be completed by the 4<sup>th</sup> of July.
