He said franchise fees have gone up and will be almost as much as the property tax income. City Manager Allen said the budget expense totals are up because of the cost of the new City Hall. He also said the committee budgeted for three full time positions, City Manager, City Recorder/Finance and Administrative Assistant. City Manager Allen said they broke up some of the funds to have a better accounting for each of the funds.
