6. <u>US Highway 97 and 1st Street/Reed Road Traffic Signal - Update</u>

Tom Blust, Director, Deschutes County Road Dept.

Mr. Blust, Deschutes County Road Department, discussed the study being done on the downtown corridor that will be looking primarily at the First and Reed intersection. He said both long term and short term solution for operational and safety issues would be explored. Mr. Blust said the study will establish cost estimates for the project and that will be key in developing a funding strategy.

Mr. Blust said the Existing Conditions Report showed that the peak traffic hours for La Pine are during the midday hours which are very different from other cities. He said the report also found that all the

intersections are operating within the standards established by both the County and ODOT (Oregon Department of Transportation). Mr. Blust said the Public Open House that was recently held will provide more information for the study. He said the final report is due out in January 2011 and it will include long term projects and cost estimates as well as there being a final Public Open House.

7. <u>Discussion of Transfer of Jurisdiction for County Roads in La Pine</u> Tom Blust, Director, Deschutes County Road Dept.

Mr. Blust stated that the Council and Board need to consider the long term eventuality of transitioning between County authority of roads within the incorporated area versus City control of those roads. The County maintains just over twenty miles of roads within the incorporated area. Tom Blust said there are no County roads in any other City except La Pine. He said the City, and not the County, has the authority to raise revenue inside the City limits for maintenance on those roads. Dave Kanner, Deschutes County, stated that once the City acquires the Water and Sewer Districts that may be the time for the City to consider taking on more roads from the County.

11. <u>City of La Pine – City Hall Organization and Staffing</u> City Manager, Rick Allen

City Manager Allen discussed staffing needs and the budget. He discussed two different options for adding an additional staff person at City Hall with the leaving of City Recorder Damerval. City Manager Allen said option one would be to have an Assistant to the City Manager and also be a Deputy Recorder. He said this position would be an Assistant to the Manager and work on projects that are needed. City Manager Allen stated that the second option would be to have someone with a planning background that could be the Community Development Manager and also Assistant Manager because of all the planning issues that come to City Hall. He said this person could become, if it was the right person, the permanent City Manager. City Manager Allen said he would not emphasize the position as a City Manager trainee, however. He said Recorders across the board do a variety of tasks. City Manager Allen said he would like a member from the public as well as a couple of Councilors to help with the interviewing of candidates. He said that they should not start looking for a new City Manager until after the first of the year with the new Council.

Councilors Hedges and McAfee were opposed to the recruitment of an Assistant to the City Manager until the new Council convenes in January 2011. Councilor McAfee stated that another reason she did not support the recruitment was that the budget could not sustain two high level positions. Councilors Greiner, Ward and Mayor Shield were supportive of option two and directed the City Manager to move forward on it.

12. Public Comments for City

Linda Johnston, area resident, stated that the Council should go with the City Manager's recommendation for the new position. Dan Varcoe, Chamber of Commerce, stated that because of the economy they should be able to get some good candidates for the position. Gloria Fleming, Planning Commissioner, stated that the City is growing and this position is needed. Stu Martinez, candidate for City Councilor, stated that they should move ahead with the position and not wait until a new Council is convened.

Austin Gillette, area resident, stated that it will take a period of time to interview and hire for this new position and the Council should not worry about it. Jim Fleming, area resident, stated that one of the best decisions this Council made was hiring City Manager Allen. He said City Manager Allen has done a lot of work in the short period of time he has been there. Mr. Fleming said there are a lot of talented people out there looking for work right now. John Huddle, area resident, stated that if you make the position interim it will limit the talent that is out there for the position so make it a permanent position.

City Manager Allen stated that there was a good response from the Architectural RFP for the feasibility study for the new City Hall. He said that on November 4th from 2 pm to 6 pm interviews will be held. He said Councilors are invited to be involved in the process as well as others. Councilors Ward and Hedges agreed to attend the interview process.
