# 3. Interview of Candidates for City Council

Don Greiner - 5:00 pm

- 7. Ordinance No. 2015-08 An Ordinance of the City of La Pine Prohibiting the Sale of
  Limited Marijuana Retail Products from Medical Marijuana Dispensaries; and Declaring
  an Emergency
  - a) Open Public Hearing

Mayor Mulenex opened the Public Hearing.

b) Staff Report

Interim City Manager Rick Allen discussed the request from Council to draw up this Ordinance. He said it was necessary to do this prior to October 1, 2015. Mr. Allen said if the Council does not do anything the medical marijuana dispensaries could start selling recreational marijuana October 1, 2015. He said the Ordinance is good through Dec. 31, 2016.

c) Open Public Comments

Robert Ottney, area resident, asked about the ban and the effective dates. Randy Huff, owner of a medical marijuana dispensary, said that this Ordinance directly effects the future of his business as well as others. He said, according to an Ordinance, that time, place and manner were spelled out for the selling of recreational marijuana. Mr. Huff said the marijuana people buy on the street is not tested and that is a serious health issue. He said it is important to keep the money in La Pine with the selling of recreational marijuana. Matt Toepher, owner of a medical marijuana dispensary, stated that he has gathered over 250 signatures from people that want the selling of recreational marijuana in La Pine beginning Oct. 1, 2015. Mrs. Toepher said that they have a lot of support for it. Rosa Mora, employee at Green Knotz Dispensary, said that not allowing recreational sales will impact her job. She also said she wanted it legalized so there would be more control of it. Steve Dowler, area resident, stated that if recreational marijuana is available he is worried that children will be able to get it. Dennis Scott, area resident, stated he agreed that it would be good to have the recreational marijuana controlled but that the residents of the City of La Pine voted against legalizing recreational marijuana. Gary Beardsly, area resident, discussed the use of medical marijuana from patients he assists. He said the dispensary stores he has visited were

very professional. Mr. Beardsly said he was in favor of the selling of recreational marijuana. Glen Costello, area resident, stated that the people who voted for the sale of recreational marijuana are having their rights taken away because now cities can decide if they want it or not. He said the sales of

marijuana is good for businesses in La Pine. Mr. Costello said that the Council is going to vote on something they do not understand. John Weatheral, area resident, discussed the revenue the City would generate in tax monies for the sale of recreational marijuana. Brad Stewart, area resident, suggested an advisory committee be formed with people who are familiar with the marijuana industry. Jason Cox, area resident, discussed how the marijuana would positively affect businesses in La Pine. Barbie Dunham, area resident and a member of TAPS, said if marijuana is going to be here it needs to be regulated in shops and provide revenue for the City. Garth Huey, area resident, said that real estate could be negatively affected by banning recreational marijuana. Todd Horrax, area resident, discussed how the County and City of Bend has worked with marijuana. He said he supported recreational marijuana being made available in the City. Don Huff, co-owner of Green Knottz Dispensary, said the Council needs to think about the effect of not allowing recreational marijuana to be sold in La Pine. The marijuana dispensary creates a safe way to distribute it. Kim McGinnis, area resident, discussed her use of marijuana due to a back issue. She said having marijuana regulated creates safety for consumers. Gina, area resident, said that marijuana saves lives. She said there shouldn't even be a meeting about banning it.

# d) Close Public Hearing

Mayor Mulenex closed the Public Hearing.

## e) Council Deliberations

Councilor Ward said the Council is not taking away medical marijuana but just wants the time to decide on regulating recreational marijuana. She said they need to decide if medical marijuana dispensaries should also sell recreational marijuana. Councilor Agan stated this will give the City time to look at the entire picture of recreational marijuana. Councilor Martinez re-emphasized that medical marijuana is not going anywhere. He said the medical dispensaries originally told the Council they did not want to get involved with recreational marijuana. Councilor Martinez said the City of La Pine did not pass recreational marijuana. He said he favors putting the issue on the ballot for La Pine. Councilor Agan said it needs to be put to a vote by the residents of La Pine. Mayor Mulenex said he also favors putting the issue before the voters of La Pine.

Mayor Mulenex called a five minute recess at 7:00 pm.

# 8. Appointment of Councilor to the City Council

Councilor Agan stated that all the candidates were wonderful. She said each of them had unique qualities and experience. Councilor Agan said she was having a difficult time deciding on a nomination. Councilor Ward stated that she has worked with some of the candidates. She said she felt experience was the most important quality for the Council. Councilor Ward said she supported Don Greiner for the Council position. Councilor Martinez stated that all the candidates were very good at expressing why they wanted to be on the Council. Councilor Agan said she would now like to nominate Dennis Scott.

# 10. Economic Vitality Roadmap Beautification Team - Request for Funding

Dennis Scott stated that first off he would like to meet with Don and Connie and get their input for his new position with the Council. He said that the Shine on La Pine committee he is on has twenty plus volunteers. Mr. Scott said they have a 90 day plan, which is to get rid of the knapp weed in the City. He said in October they plan to contact the various businesses in La Pine for a pledge to keep the City looking nice and free of knapp weed. Mr. Scott said that the committee will also address the signage in the City, sometime next Spring. He said they plan to acknowledge businesses that participate in the beautication goals. Mr. Scott said they are asking the City for the cost of the signs that are needed for knapp weed removal.

Councilor Ward asked if the City had the money for the signs. Mr. Allen said that the revenue from the business licenses was available for this type of use.
