Councilmembers:

The Budget Committee will need to hold a hearing about the decision to accept State Shared Revenues. This hearing provides the public with an opportunity to comment on how these dollars are spent. Shared Revenues are the City’s portion of liquor, cigarette, and marijuana tax. Also, there is a quarterly apportionment based on population that the City receives.

***The process for the Public Hearing is as follows:***

***Open the public hearing***

The chairperson will say, “This is a public hearing of the City of La Pine’s Budget Committee for the City to receive State Shared Revenues. Ashley Ivans will provide a staff report.”

***Staff Report***

I will provide a very brief verbal staff report.

***Public Comments***

The chairperson will now say “The hearing is open for public comments” – you can set time limits on these comments if there are any. Once all the comments have been received, the chairperson will say “Public Comments is closed”

***Deliberation***

Now, the chairperson will say “The floor is now open for deliberations from the Budget Committee”. If any member has a comment now is the appropriate time to state it. Discussion amongst the committee also is conducted during this time. **However, no decision is made.**

***Close the Public Hearing***

Once the deliberations are complete the Chairperson will say, “this public hearing is now closed.”

After closing the public hearing, the chairperson should ask for a motion to approve the City of La Pine Budget. The recommended motion is below.

***Motion Recommendation:*** I move that we approve the City of La Pine FY 2026-27 Budget.
