# 6. Applicant Interviews

#### Chamber of Commerce – Dan Varcoe

00:05:07

Dan Varcoe, Chamber of Commerce gave a brief review of the Governor's Conference on Tourism that he recently attended. He said it was stated at the conference that for every dollar that is spent to promote tourism, about five dollars comes back to the city or public entity. He discussed getting volunteers to paint and make some improvements around the City to attract more tourists. Mr. Varcoe encouraged the TRT Committee to look at the big picture which in La Pine is economic development.

#### 00:11:43

Chair Uecker stated that he had a discussion with City Attorney Green, today regarding pending issues from the last committee meeting. He said the name of the committee and also term lengths will be determined at a future City Council meeting. Chair Uecker stated that as he understood it, there needs to be a clear connection between the activity and putting people in motels or it does not clearly fit within the statutes. He said he did not have time to address the fiscal year issue with City Attorney Green. Art Uecker said when an event takes place in a remote area it is difficult to justify the event qualifying for TRT funds. He said the event needs to bring in people from over 50 miles away and/or have them stay in a local motel. Chair Uecker said they will put the facts of an application together and the Council will make the determination. He suggested discussing these issues with the Ponderosa Man Event representative that is here at today's meeting.

## <u>Ponderosa Man Event – Representative</u>

#### 00:21:55

Mr. Steve Crabill, representative from the Ponderosa Man Event, briefly gave a history of the event and the 'mountain men' that used to live in the Cascades. He said it is necessary for the event to take place at a remote location due to the nature of the event and the use of guns during activities. Mr. Crabill stated that the event will be held off Hwy 58, near Crescent Lake. Robin Mirrasoul expressed concern about the location being so far from La Pine that it was likely people will use resources for housing and supplies closer to where the event will be held. Chair Uecker stated that he has concerns as well regarding the City Council providing funds for an event that is so far away from the City. He said, however, that the Mountain Man event during the La Pine Frontier Days would easily qualify for TRT funds and he would like for them to apply for that opportunity. Ms. Mirrasoul recommended Mr. Crabill's organization seek tourism funding from Klamath County since that is where the Ponderosa Man Event will be held.
