5. Applicant Interviews

High Lakes Car Club – Randy Rhoades

Chair Uecker discussed the time frame for applicants to use the funds they are currently requesting. He said that the problem with the High Lakes Car Club's application request was that it requested funding for this fiscal year, prior to July 1, 2010. Unfortunately, the grant applications are only for the 2010-2011 fiscal year that starts after June 30, 2010.

Randy Rhoades, representing the High Lakes Car Club, stated he was unsure of how the time-line for grant applications actually worked. Lupita Lewis suggested changing the application request date to the 2010-2011 fiscal year.

Chair Uecker suggested Mr. Rhoades redo the application and make it applicable to the coming new fiscal year so it could be eligible for TRT funds for that time period. He also advised Mr. Rhoades to contact the Chamber of Commerce and see if they had any remaining TRT funds for this current fiscal year to help with the event in two months.

Mike Jensen suggested that, regarding the advertising for the event, the Car Club should breakdown what amount of advertising they plan to do in the Bulletin and other newspapers. He also recommended checking out the Redmond Spokesman as another newspaper to advertise the event.

Chair Uecker stated that anything being sold by the Car Club could not have TRT funds used to produce or sell it, but if they were giveaways and advertised La Pine in some way, then they would probably qualify. Mike Jensen also said that sponsored items like trophies could not be paid for with TRT funds.

Chair Uecker also requested that the Car Club provide the Tourism Committee with a report of where the people came from that attended last year's event. He also suggested that the breakdown of that information might be something to go on the City's website.

Ponderosa Man Event - Representative

There was no representative available from the Ponderosa Man Event. Chair Uecker said that interview will be scheduled again to occur at the April 20th Tourism Committee Meeting.

Chair Uecker stated that Park and Rec needs to come to the April 20th meeting for their interview. Robin Mirrasoul will make arrangements for that to happen. Mike Jensen will follow up with Dan Varcoe to obtain additional information regarding the Ponderosa Man Event.

Linda Johnston suggested changing the name of the Tourism Committee because they do not handle any marketing; they simply screen applicants for TRT funds. Chair Uecker stated he will be discussing this issue as well as other issues on Monday, April 19th with City Attorney Green. He also said he will be reviewing the State statutes regarding TRT funds with City Attorney Green. Lupita Lewis said that the statutes are not clear about the overnight stay issue.
