5. Presentation of FY 2016-2017 Budget

Mr. Allen discussed the Budget Message. District Identity: transportation improvements, planning and development assistance programs, debt service, administration and property acquisition. He said they except to receive \$23,500 in revenue for r the next year. \$22,700 was the amount of revenue from last year. Mr. Misley said they want to spend \$5,000 from the budget, on the Sustainable Cities Program. He said the City has budgeted \$40,000 for the program with \$5,000 coming from Urban Renewal revenue. Mr. Misley said one of the programs they would be working on would be for revitalizing of the downtown area of La Pine. He said the project would give the City plans so that when money comes from Urban Renewal the projects could be implemented. Mr. Misley said the Ford Family Foundation will also be coming in with \$40,000 to match the City's amount.
