9. SCYP Presentation on Transit/City Center Concept and Discussion

Zoe, Austin and Jared, SCYP students from the University of Oregon, were included via teleconference to give their presentations. The Urban Renewal Agency introduced themselves. Cory Misley provided a summary of the SCYP thus far. The students presented their design concepts. There was discussion on the parking and landscaping design on Austin's site plan presentation. The agency gave their praise and feedback. Scott Aycock with COIC was in attendance and stated that he was looking forward to how these presentations tied into the major themes taken from the survey completed by the public. He also stated that there is \$10,000 set aside to help with this project.

10. Presentation by Gary Gordon, La Pine Parks and Recreation Board Chair

Gary Gordon gave a presentation on behalf of the La Pine Parks and Recreation District. This included a brief history of the district, the district boundaries and how it related to city limits and urban growth boundary, and the history of the 150 acre event center. There are some major issues with developing the 150 acres, which were laid out in the presentation. The District is looking into the possibility of planning grants and would like URA assistance. The District will be requesting the County revise the use of the 150 acre parcel. There is a property for sale on Old Main Court that the District would like to purchase which would allow the skate park to be moved and add additional parking for Heritage Park. The District cannot afford to buy the property at this time and is asking the URA to assist.

There was discussion by the URA on priorities for the park district and waiting to expand until the current district properties are cared for entirely. Cory recommended having a meeting in the future to discuss if and how the URA wants to contribute to the Parks and Recreation District.
