  - a) Open Public Hearing

Chair Gloria Fleming opened the public hearing.

b) Staff Report

Cory Misley stated that three weeks ago the City Council of La Pine voted to put retail recreational sales on the ballot in November for the voters of the City of La Pine to decide whether to allow or prohibit. They did not include, in the ordinance, growing or production, processing, packaging and wholesaling. He said several interested parties want to grow marijuana in the Industrial Park. Mr. Misley said there needs to be a decision on what the City wants the industrial park to look like. It is not designated for agriculture. Mr. Misley then discussed hoop houses not being allowed. He said modular structures come in on wheels but when transferred onto the ground and placed on a foundation, they become a building.

#### Changes can be Found in Ordinance 2016-03 Exhibit A

Ms. Wisco stated, regarding legislative procedures, a Hearing is required. The city has filed all the procedures and posted notice of the public hearing as well as advertised in the local newspapers. Ms. Wisco reviewed the state wide planning goals that are addressed in the amendments. She said staff recommends the indoor agriculture proposed amendments to the City Council.

Councilor Fleming asked about a site plan for the growing operation that is there now. Mr. Allen said that it was built as a rental building and was done when the County was still handling planning for the City. Ms. Wisco then reviewed the general criteria for conditional use permits. Commissioner Greiner stated that the information on how it will be controlled appears to have adequate safeguards in place.

#### c) Public Comments

Christopher Smith, property owner in the Industrial Park, said he owns three lots that will be involved in marijuana production. He said OLCC has a large number of requirements and guidelines for the processing of marijuana. Mr. Smith said there is also a land use compatibility form that needs to be signed off by the City of La Pine. Ms. Wisco said the City just wants to make sure the modular are affixed to a permanent foundation. Ms. Wisco said, regarding storage containers, they would not be allowed for indoor agriculture processing. She said they would be allowed for equipment, specifically for equipment storage in the industrial zone. Kevin Haas, area resident, read a statement about how the City of La Pine lost revenue by not legalizing recreational sales in the City.

#### d) Close the hearing

Chair Gloria Fleming closed the hearing.

Commissioner Ward said he did not like shipping containers and that there are too many in the City. Vice Chair McClung said he did not like storage containers at all. Mr. Allen said that shipping containers are historically used in industrial areas.
