7. Update on Affordable Multi-Family Housing Development

Mr. Misley said he receives a report on a monthly basis from Deschutes County of what building permits were issued during a month, in the City of La Pine. The City has control over land use and a builder must make application to the City regarding zoning. The monies collected by Deschutes County, for job value in the City, now has a percentage that goes to the City for planning tasks. Mr. Misley stated that the charges for SDC (System Development Charges) will probably be going up in the near future. There was also a discussion on the Public Hearing regarding Housing Works at the November 9, 2016 Planning Commission Meeting.
