### 1. Call to Order

Chair Ward called the meeting to order.

### 2. <u>Establish Quorum</u>

3. Pledge of Allegiance

Commissioner Norman McClung led the Pledge of Allegiance.

4. Added Agenda Items

Any matters added to the agenda at this time will be discussed during the "Other Matters" portion of this Agenda.

City Manager Steve Hasson gave a brief introduction on his background in planning. He also discussed that hopefully the final review of the Comprehensive Plan by DLCD (Dept of Land Conservation and Development) will occur in July. City Manager Hasson also said he read the IGA (Intergovernmental Agreement) with the County for planning services to July 1st. He stated he would like to push the expiration date on that IGA out to August 1st. City Manager Hasson discussed the concerns he had to the back—up materials for the Historical Codes Ordinances and provided the Commission with those changes. He said he asked to have the Ordinances continued to the next regularly scheduled Council Meeting on April 11th so he would have time to review them and address his concerns. City Manager Hasson also stated he had to rewrite some of it because it needed a stronger sentence structure. He said he has shared the changes with Deborah McMahon, the planning consultant for the City. City Manager Hasson stated on the Comprehensive Plan materials he had made no changes. He said it was really the code enforcement that he made changes to and in no way was trying to be disrespectful to the work that Pat Kliewer had done. City Manager Hasson also said he will be bringing back the sign ordinance to the Commission. He said, in his opinion, that the current sign ordinance is way too lengthy. City Manager Hasson stated he is a minimalist when it comes to property rights and the Fifth Amendment. He also said the local jurisdiction ought to be the one that is tough with land use regulations instead of the State.

### 6. Approval of Planning Commission Meeting Minutes

- February 15, 2012 Meeting Minutes

A motion was made by Vice-Chair Thomas and seconded by Commissioner McClung to approve the Minutes from February 15, 2012.

Motion passed unanimously.

#### 7. Goals and Priorities

Vice-Chair Thomas stated that a goal could be having DLCD completely satisfied this year. Chair Ward stated that DLCD had some strange ideas. One of their ideas is no one should have a house on any acreage, just a lot. He said Deborah McMahon, planning consultant, had done a good job of communicating the community's needs to DLCD. Ms. McMahon said that the number one goal should be to finalize the comprehensive plan process and the implementing process. She said they push at every meeting to get the DLCD to understand that La Pine is not like other cities. Ms. McMahon said that the public wanted codes written for their needs.

Vice-Chair Thomas thought another goal, for this year, would be getting a planning department up and running in La Pine. He said he was excited to have a planner come onboard as the City Manager.

Chair Ward stated that one of their goals would be what the Planning Commission should recommend to the City in so far as signage, traffic, nuisance, etc. City Manager Hasson said he recently purchased a camera and camcorder for the City to do code enforcement in the City. He said when you send out an enforcement letter you want to send along a picture of what is the issue. City Manager Hasson said as long as the Sheriff is onboard you can go on a gradual enforcement process. He said the first step is to talk with the homeowner prior to sending out letters. City Manager Hasson said then letters are sent out with an eventual letter from the City Attorney prior to taking action to prosecute.

Ms. McMahon stated that it is important to prioritize enforcement goals. She said things that effect property value should rise to the top. Ms. McMahon said public safety is number one. She suggested categorizing things in accordance with the ordinances that are enforced. Ms. McMahon said they cannot respond to every concern, it would be too time consuming. Vice-Chair Thomas suggested doing public outreach to make residents aware of these issues. City Manager Hasson stated that he likes to do demand/delivery. That is, unless it is really outrageous he waits until the problem comes to the City. He suggested making a list of ten things that are the most nuisance issues. City Manager Hasson stated that he would do a comparison of the top ten nuisance issues with his past employer, the City of Kuna. He said the top ten for there would probably be similar to here.

### 8. Review of the Comp Plan and Zoning Map

Deborah McMahon stated that as strategy and as a way to be more effective they had talked about the Chamber of Commerce becoming a partner with any enforcement plan. She said it would be good to have as much outreach and public involvement as possible for enforcement.

### 9. Review of Training Resources and Materials

City Manager Hasson said he will bring his books on planning to be included with the current planning commission library. He also thought it was important that the Planning Commissioners be members of the APA (American Planning Association). City Manager Hasson said that land use planning is critical. He said they must be careful of how they apply codes and procedures to not impair the economic engine.

There was also a brief discussion of the lot subdivision that St. Vincent de Paul's have applied for with the County.

### 10. Planning Commissioner Reports

Chair Thomas recommended that the Commissioners take some seminars offered through the League of Oregon Cities. He said the City will reimburse for training opportunities. He said being a Planning Commissioner is a very important job.

Chair Ward stated that he will not be able to attend the April 18<sup>th</sup> Planning Commission meeting as he will be on vacation. He also discussed the Board Training Retreat scheduled for March 23<sup>rd</sup>/24<sup>th</sup>. The Commission decided on a start time of 5:30 pm for the April 18<sup>th</sup> meeting.

#### 11. Other Matters

City Manager Hasson said the whole issue of land use planning is very complicated. He said they have to take into consideration all the differences of each parcel. City Manager Hasson said that you want in a community every property to have value as it can be developed. He said the challenge is how do you have rules that work and still allow for development and growth.
