A. Work Session - 5:00 pm

1. Call to Order

3. Discussion on Historical Preservation Code

Pat Kliewer, from Kliewer Engineering, stated that the first document the Commission had was the City of La Pine's Comprehensive Plan Chapter 5 – Historic areas and Historical Cultural Resources. She said the La Pine Cemetery and the Grange are the only two properties that were designated as historically significant resources by the County in 1991. Ms. Kliewer said the development of the area was held back because of transportation issues. She said the important part for the Commission is the section that is called La Pine's Historic Preservation Goal.

In response to a question from Deborah McMahon, DMC Consulting, Ms. Kliewer said that small changes (i.e., typos) do not have to go through the legislative process but if you add something in then the Board has to approve it.

4. Discussion on New Section of Comprehensive Plan regarding Historical and Cultural Resources

In response to a question from Chair Thomas, Ms. Kliewer said that there should be a separate Landmark's Commission apart from the Planning Commission if there are enough people interested to fill vacancies. She also said that five members is a good size for the Landmark's Commission. Deborah McMahon said that the Landmark's Commission must get trained and there is a training session on April 19, 2012. Ms. Kliewer stated that she would also be available to do a training session for the commission.

- 5. <u>Public Hearing on Historical Preservation Code and new section of Comprehensive Plan regarding Historical and Cultural Resources</u>
 - 1. Open Public Hearing

Chair Thomas Opened the Hearing and read the procedures for Public Hearings.

2. Staff Comments

Deborah McMahon stated that it was good that the City received a grant for Pat Kliewer to work and produce Goal Five the Historical Cultural Resources as well as the Historical and Cultural Preservation program and Landmark's Commission data that will go in the Ordinance. She said these two features helped complete the Comprehensive Plan and the implementing Ordinances.

Pat Kliewer stated one of the documents stated how to set-up a Landmark's Commission and then sets out the goals of the preservation code and tells how to designate new buildings and protect other buildings. Chair Thomas said that the Landmark's Commission will only apply to buildings that are in the City limits. Deborah McMahon stated that they can advertise for volunteers to sit on the Landmark's Commission and also inform them about the training that will occur in April. In response to a question from City Manager Allen it was stated that the Planning Commission can also be the Landmark's Commission. Ms. Kliewer said that provision is in the code.

3. Public Comments

Gary Shogar said his wife Cheryl is the Master of the Grange for La Pine. He said if the building is listed as historic then they would like to know what types of restrictions might apply. Pat Kliewer stated that there is nothing in the code that goes inside the building. There will be no regulations regarding the interior of the building. Any maintenance, including roofing, is allowable. Ms. Kliewer said that the Grange was designated in 1991 by Deschutes County as an historic building. Deborah McMahon suggested waiting to do the roofing on the building until the City's code is in effect as it is more liberal than the County's code.

4. Close Public Hearing

Chair Thomas closed the Public Hearing.

5. Planning Commission Deliberation

Commissioner McClung stated that the code is very comprehensive and not too heavy handed. He said it was very thorough and he would highly recommend it. Commissioner Ward stated that he had two recommendations to consider. He said number one is to recommend to the City Council that the Planning Commission becomes the Landmark Commission until such time as there are resident volunteers for the Landmark Commission. Commissioner Ward also recommended that La Pine have a Historical District. Pat Kliewer stated that an Historical District would not have to include every building located in the District. She also said the code already has procedures for creating a Historical District.

A motion was made by Commissioner Ward and seconded by Commissioner McClung to approve the documents presented which are the ordinances approving the addition to the comprehensive plan and the addition to the implementing ordinances as amended with the exchange of the photo, the recommendation that the Planning Commission serve as the Landmarks Commission and that one of the first tasks be the study and determination of the City's first Historic District.

She was eliminated because the open position is for a resident. Ms. Agan, a City resident, has also applied to be on the City Council so no decision was made on her application at this point in time. Ms. King's application will remain on file for when a non resident vacancy position opens up.
