7. Ordinance No. 2011-04

An Ordinance Adopting Code Section 10.1.0 Expiration of Approval and Declaring an Emergency.

a. Open Public Hearing

Chair Thomas opened the Public Hearing.

b. Staff Report

Deborah McMahon, DMC Consulting Inc., stated that extending the land use approvals does not harm the public health in any way and helps local business. She said in order to do this an ordinance must be in place. Ms. McMahon said it will involve time extensions for existing sub divisions. She said most cities have some type of extension.

8. <u>Discussion on New Ordinances, Immediate Effect and Enforcement</u>

City Manager Allen stated that a group has been formed to review the sign code ordinance. He said that they wanted to increase the size of a sign for multifamily or subdivisions from 16 feet to 24 feet. City Manager Allen said that was their first recommendation. He also said that for Church signs most of them were bigger than 16 ft and the group asked to go to 32 feet for a second recommendation. City Manager Allen said that the most controversy is with the banner signs. He said they recommended if it is a community based event that the City approves of, it would be exempt from the restrictions on banner signs.

Deborah McMahon stated that pole signs are usually on highways and not in other areas because people need more time to react to them. She also said the compliance date for signs is July 1, 2016. Ms. McMahon stated if most signs are out of compliance the Planning Commission might want to make changes regarding the requirements. She said signs are allowed for residential businesses.

Robin Mirrasoul stated that regarding the definition of pole signs almost every one of them in the City is out of compliance. City Manager Allen said that the wording needs to be changed for pole signs in order to not have this

problem. Ms. McMahon said there are no restrictions on off property signs as long as the sign is in conformance to the sign requirements.

It was decided to change some wording and come back, at a future meeting, with a list of sign issues.

9. <u>Discussion on Budget for Training and Code Enforcement</u>

Deborah McMahon recommended looking at goals to determine what areas to focus on in the way of training opportunities. Chair Thomas discussed a Planning Commissioner's workshop at the League of Oregon Cities annual conference in Bend. He also discussed another Planning Commissioner training opportunity in Eugene during the month of September.

Chair Thomas stated that there is a budget for code enforcement. City Manager Allen said it would probably be a contracted employee rather than a City employee and start sometime next year. He said the City Manager will probably do a lot of code enforcement work as well.

Deborah McMahon stated that the Planning Commission has accomplished a lot for the time it has been in operation.

City Manager Allen stated that because of the size of the City and the tax rate, the City will not provide a lot of services now or in the future. There was also a discussion about the flea market located off Highway 97. City Manager Allen said that there is not a lot that can be done about how it looks at the present time. He also discussed the 'branding' that LIGI (La Pine Industrial Group) is exploring for La Pine.

Chair Thomas stated that he recommended that Little Deschutes Lodge needed to complete their landscaping plan from Phase 1. He said they need to be told that the City is fully behind their venture but that they need to finish the landscaping. Councilor Greiner stated that they ended up with less water than what they needed. Deborah McMahon stated that in the response from the City to the Deschutes County Planning Department she is putting down that they (Little Deschutes Lodge Phase 2) meet all conditions of previous approvals including landscaping plans and trails.

Councilor Greiner suggested the Commission invite Rob Roy to a meeting to discuss his plans for the development to the Commissioners. It was discussed that Chair Thomas would invite Rob Roy to the August meeting.

She also said that doing a TSP (Transportation Systems Plan) is another goal for the Commission.

Vice Chair Fleming stated she would like to write an article for the Newberry Eagle about what it's meant to her to be a Planning Commissioner.
