# 7. <u>Discussion of what the Planning Commission has been Doing</u>

Vice Chair Fleming stated that when the Commission first started they had a series of meetings with the public about the Comprehensive Plan. She said with the help of the planning consultants they were able to bring a good Comprehensive Plan before the Council for approval. She said only minor changes were made by the Council and also public comments.

Vice Chair Fleming stated that next the Commission started working on their first ordinances on zoning. She said there were a number of meetings and the Commissioners were all in favor of what was agreed upon. Vice Chair Fleming said that they knew there would be some controversial issues once the zoning ordinances went before the Council and public. She also said that the County would not enforce their own ordinances because the city was incorporated. However, this has led to a number of complaints from the residents of the City.

Vice Chair Fleming said the Commissioners common philosophy had been to recognize the uniqueness and the desire to maintain a small town feel. She also said that the Commission looked at other rural communities and compared the City's ordinances with them. Vice Chair Fleming said that the significant snow fall also had to be factored into some of the ordinances. She said controlling lighting to protect the night sky was important to all the Commissioners. She also said that they tried to keep the ordinances as simple as possible to make it easier for the residents when applying for various permits, etc. Vice Chair Fleming stated that the Commission tried hard to get feedback from the community as well as from the planning consultants. She said since the zoning ordinances cannot be put into effect until the Comprehensive Plan is approved, there is time to refine the ordinances as needed. Vice Chair Fleming stated that if the Commission turns down an application they (the applicant) can still go before the Council for an appeal.

Vice Chair Fleming stated that the new Commissioners need to get use to the Comprehensive Plan. Commissioner Ward congratulated the Commission on the zoning ordinances. Commission Ward stated that to enforce code violations it will take hiring a code enforcement officer and then having the patience and time for enforcement. In regard to banners, Councilor Greiner stated that right now the City cannot enforce the only one banner per event. Vice Chair Fleming said an exception could also be made.

Vice Chair Fleming stated that Deborah McMahon and James Lewis had done a great job as planning consultants. Councilor Greiner said, regarding the flea market on the north end of town, the City Manager was going to visit it and try to get a hold of the owner of the property. He said people were illegally living on the premises as well.

Vice Chair Fleming stated that there had been no by-laws or rules created by the Commission. She said that maybe a good topic for discussion in the near future.
