7. 51540 Huntington Road, Car Wash Site Plan Update

Tammy Wisco, City Planner, discussed the Car Wash Project. She said it has been reviewed and there are some conditions that need to be meant before approval. Ms. Wisco said they are looking for some additional and revised documents from the Car Wash Project.

8. <u>Burgess/Skidgel Storage Unit Update</u>

Ms. Wisco said that the City has just received this application. She said the new owner has purchased additional property and want to extend their storage unit business to the new property. There is a lot line adjustment and a partition involved with this application.

9. <u>Legislative Rezone Update</u>

Tammy Wisco discussed the zoning map and the comprehensive plan map. Now that the City has a transportation system plan in place the City can go ahead and rezone parcels to get them to the comprehensive map plan zone. She said that there would be a public hearing on the re-zoning. Ms. Wisco said that by the next Planning Commission Meeting she will have more information on the re-zoning.

10. Natural Hazard Mitigation plan "heads up"

Ms. Wisco said each of the Cities need to complete a natural hazard mitigation plan. Then it would be submitted to Deschutes County and then eventually to FEMA (Federal Emergency Management Agency). She said a public hearing would be required as part of the process. Mr. Allen stressed that there is little the City of La Pine would be involved with except concerning water since the City has no fire, police, or road departments.

11. <u>Discussion of Special Meeting on Development Updates</u>

Cory Misley discussed the New Haven Project and having a Work Session on the project. Mr. Allen said the original rules and regulations for the City probably need some changes because they were done early in the incorporation of the City. He said the process also needs to be upgraded. Mr. Allen said they would have the meeting in the next 3-4 weeks. Mr. Allen said he wanted the Planning Commission to have an opportunity to ask questions and express any concerns they may have about the project.

PUBLIC COMMENT

Dennis Scott, area resident, asked about the proposed Credit Union. Mr. Allen said it is in the building permit process. The County is handling this process. Mr. Misley said he has had a lot of questions about mini-storage facilities. Mr. Allen said Habitat for Humanity wants to put in about 13 townhouses. It would involve basically taking 50 foot lots and cutting them down to 25 feet. Mr. Scott discussed the "Shine on La Pine' and said he is receiving calls from businesses inquiring about it. He said they are visiting businesses and trying to get them to sign-up for the project. Mr. Misley said the City supports it and likes the community involvement approach. Councilor Agan asked if the color of the roof for the Mid-Oregon Credit Union that will be built in La Pine would be colored blue. Mr. Allen said that there are problems with requiring certain colors to be used in a community and currently the City of La Pine does not have a color requirement.

Commissioner Fleming said she has been busy pulling weeds. Commissioner Greiner asked about the planning books that were distributed to the Commissioners.
