Planning Commissioner Gloria Fleming mentioned that she was only a temporary representative from the Planning Commission and not a permanent member of the Utility Committee. A permanent representative will probably occur when the commission increases its membership, right now there are only three Commissioners.

City Manager Allen suggested not having three councilors on the committee. Linda Johnston stated that she would be willing to sit on the committee since she has already been selected for the future Public Works Committee. Councilor McAfee stated that she would like to stay on the committee since she was involved in the creation of the committee. Mayor Mulenex said that he would not necessarily have to continue to be on the committee so there would not be three councilors on the same committee.

Chair Scholer reminded the committee that the Utility Committee will be dissolved in the future because of the Public Works committee that would be formed.

6. <u>Continued discussion on Water and Sewer Districts Withdrawal</u>

City Manager Allen stated that another letter was sent to the Districts asking them to move forward with the withdrawal. He said the Water District Board does not wish to do this at the current time. City Manager Allen said that the Districts believe the Council is not knowledgeable about the loans from USDA (United States Dept of Agriculture). He said they could have a presentation done by USDA at the April 13th City Council Meeting.

Chair Scholer stated that all these excuses come up so the withdrawal progress is back to square one. Vice Chair Benner said that in her dealings with the District she has found their attitude unyielding. City Manager Allen stated he would like to have the meeting after the withdrawal request letter is sent out. He said he expects the City to have many conversations with USDA over the next several months. Mayor Mulenex said he was in favor of the meeting. Councilor McAfee stated she did not feel the meeting would be productive. She said a technical person is needed to be able to run the Water and Sewer Districts so that the process would run smoother. City Manager Allen said there probably needs to be a City Manager who also has public works experience.

City Manager Allen said that when the City absorbs the Districts they keep the same loan interest rates, etc. Mayor Mulenex said we could get some beneficial information from a meeting with USDA and also satisfy the Districts that the Council has been educated and that would be a good thing.

City Manager Allen stated that the District's want to do a survey of their customers to see if they are in favor of the withdrawal. He said the survey results in and of themselves are not really going to be that significant. City Manager Allen said the survey will not have any bearing on the City continuing with the withdrawal. He said the Districts complained that there were not very many residents or their customers at the recent Public Hearing.
