7. <u>Continued discussion on Water and Sewer Districts Withdrawal</u>

City Manager Allen stated that last month the City requested a number of documents from the Water and Sewer Districts. He said the Districts are going to send them an estimate of what it will cost in labor and materials to produce these documents. City Manager Allen said intentionally they are not providing things in an efficient manner. He said thousands of dollars are going out in legal fees for both the Districts and the City. City Manager Allen said that attorney Neil Bryant is also working on behalf of the City.

Tony Debone stated that all the City services need to be consolidated and he supports the withdrawal of the Water and Sewer Districts. City Manager Allen stated that the districts have voted to not support the withdrawal at their last meeting. He also said the City has written a letter to the County asking that they not support the Cagle annexation by the districts. City Manager Allen said that the funding for that annexation is a long ways out.

City Manager Allen stated that the City would like him to start working on how they would run the districts. He said they may have to hire staff if they go in that direction. City Manager Allen stated that the City will probably record the Districts' meetings and put them on the City website. He said the culture operating at the Districts now will be quite different than the culture when the City is operating the Districts.

There was also a discussion of what seats on the District's board will be expiring in 2011. Tony Debone stated he would need to resign from this committee given his recent election to the County's Board of Commissioners.

8. Public Comments for Items Not on the Agenda

Vicky Jackson, area resident, discussed the costs of legal work that will affect the residents. She said there will be a lot of upset people when they understand how much money is going to lawyers.

Stu Martinez, Councilor elect, also expressed concern about the attorney fees both for the City and also for the Water and Sewer Districts and the resident's reaction to them.
