7. Update on the Water and Sewer Districts and Biogreen

City Manager Allen stated that once the Biogreen application is considered 'complete' then there is a fourteen day period for agency comments and review. He said the timeline, according to Nick Lelack from the County, is for the decision to be made in mid October. If all goes well, Biogreen may have their permit sometime in December 2010.

This item was moved forward for organizational purposes.

10. Public Comments for Items Not on the Agenda

Jake Salcone, via telephone conference from RCAC (Rural Communities Assistance Corp) stated that RCAC would like to provide some assistance if the decision is made to do a withdrawal of the Water and Sewer Districts. He said he could provide training on budgeting and rate settings, etc., for both City and Special District people. Mr. Salcone stated that usually RCAC enters into a service agreement that outlays roles and responsibilities. He said he would put together a draft service agreement for review by both the City Council and the Special Districts.

He said that an analysis, done by USDA, would have to be completed and it may be possible through an Intergovernmental Agreement to satisfy both the City and Districts. City Manager Allen said the annexation is important to the Special Districts.
