Councilor McAfee stated that City Attorney Green had said that the Agreement is currently in the District's hands. Donna Zigler said that she talked with the District's attorney today and the Agreement had just been forwarded on to City Attorney Green. She said that she believed the Agreement is for a 32 month time period.

10. Report on Rural Community Assistance Corporation Conference in Pendleton

Ted Scholer, Chair

Jake Salcone, RCAC (Rural Communities Assistance Corp) stated this was a training workshop presented about water and wastewater infrastructure financing. He said various agencies spoke about the types of loans they had available for infrastructure. Chair Scholer discussed the one stop shop when all the funding agencies and the applicant have a telephone conference and discuss the various programs available. He also discussed the House Bill 3619 regarding City absorption of Special Districts. Jake Salcone stated that HB 3619 pertains to Cities that have not yet incorporated.

The committee had consensus for City Manager Allen to request, from City Attorney Green, the legal analysis on the absorption of the Districts for the next meeting. Jake Salcone stated that since the District's hold debt with rural development, the City would have to show that they could afford to take on that debt. He said that security for the debt is usually done with a general obligation bond or a revenue bond.

Vice Chair Benner said that she will work with Pam Swires of USDA (United States Dept of Agriculture) so that the Performa budget will be done in compliance with the USDA. Jake Salcone said that a general obligation bond would be assessed to everyone in the City and would have to go to vote. He said a revenue bond does not have to go to vote but it can be contested.

### Adele McAfee, Councilor

Councilor McAfee stated that she went through the Resolution for the committee and broke down the duties based on that Resolution. Vice Chair Benner suggested doing research on revenue bonds based on the timeline. Chair Scholer suggested a committee be formed specifically for absorption of the Districts if the Council decided to pursue it after this committee had completed their duties. Vice Chair Benner suggested another Town Hall meeting be held after this committee submits their report to the Council. Planning Commissioner Classen suggested that residents affected by the absorption should be informed about the positive benefits of this occurring. Ken Mulenex stated that as the committee covers each duty they will get a better feel for both the positive and negative sides of the absorption.

### 11. Public Comments for Items Not on the Agenda

Vicky Jackson, 17346 Mink Court, asked if everyone in the City limits was on the District's water and sewer lines. Ken Mulenex stated that Glenwood Acres and the Cagle Subdivision were not serviced by the Special Districts. Donna Zigler said the Districts are getting ready to annex those two areas in addition to some other areas. She said the process is that the Districts go to Deschutes County and request annexation of the areas.
