1. Call to Order

Chair Scholer called the meeting to order at 4:00 pm.

2. <u>Pledge of Allegiance</u>

Chair Scholer led the Pledge of Allegiance.

3. Introductions

Rene Schifano, applicant for this committee, Donna Zigler, from the La Pine Water and Sewer Districts, and also Art Uecker, insurance agent for the City of La Pine, introduced themselves.

6. <u>Update on Insurance and Legal Fee Costs</u>

Art Uecker, La Pine Insurance Center

Mr. Uecker discussed the Water and Sewer Districts liability policies and that he had sent them to CIS Insurance (Insurance Carrier for the City of La Pine) along with a loss report for the three claims of the Districts. He said there are three substantial losses over the last three years in regard to

workers' comp and also a general liability claim. Mr. Uecker said as a result of that, CIS Insurance had the following response, 'they would need an explanation of the large claims, and they would have to send out risk management to do an investigation of the current job descriptions, risk management, etc.' He said that they gave a ballpark figure of an \$18,000 to \$20,000 contribution to add the Water and Sewer Districts to the current City's liability policy. Mr. Uecker said they would need workers' comp cost quotes and payroll associated with each of them to quote the workers' comp. He said they would want more details on the losses. Mr. Uecker stated that it is about a wash on the general liability but workers' comp is a whole different issue and more research is needed.

Ms. BarbeAnn Nelson-Dodson suggested writing a letter to the Districts requesting needed documents. She also said that the person who had the workers' comp claim no longer works there. Ms. BarbeAnn Nelson-Dodson said that the general liability claim is still ongoing.

Mr. Uecker stated that he can provide a health insurance quote once he has received the cost quotes and payroll from the Water and Sewer Districts. In response to question, asked by Councilor McAfee, regarding if the Water and Sewer District employees would get the same benefits as the current City employees, Art Uecker said that they would be able to pick and choose which benefits they wanted like the City employees are able to do.

Patti Morgan, Administrative Assistant, stated that, according to Roger Jordan, Range Rider for the League of Oregon Cities, there were State of Oregon laws that protect public employees. BarbeAnn Nelson-Dodson said there were some rules that apply to titled positions.

10. Report on Infrastructure Workshop

Ted Scholer Jake Salcone, Rural Communities Assistance Corporation

Chair Scholer said this was a funding financial workshop on infrastructure. He suggested that it would have been an excellent opportunity for someone from the Districts to attend. Ms. Nelson-Dodson said the Districts have put in several applications for assistance and some of them are waiting on the City's approval of their comprehensive plan.

Chair Scholer talked about the State of Oregon (low interest) safe drinking water fund that is available. He said the opportunity for rural development funding was especially interesting including an asset management program. He talked about an assessment program called 'cups' that is a detailed inventory of the whole system, maps and also included a history.

13a) Resignation of BarbeAnne Nelson-Dodson from the Utilities Committee

Ms. Nelson-Dodson stated that after reading the Utilities Committee Resolution to the Board and discussing with them the voting rights contained in the Resolution, the Board asked her to resign from the committee and not be a participant. She said she has prepared a letter of resignation for Chair Scholer.

Councilor McAfee stated that she felt Ms. Nelson-Dodson's role with the committee would be to participate in how things were going to be organized in the future like having a Utilities Commission that would have a similar function to what the Board is currently performing.

Ms. Nelson-Dodson stated that the Board did not like several things in the Resolution and felt it would be better if the committee requests paperwork from the Districts rather than have her just bring them documents. She said they feel that she has brought the committee enough facts and that her job there is done.

Chair Scholer stated that with a participant from the District, that would give them an opportunity to be a part of the discussion and decision of the eventual absorption by the City. He also said it was up to the City Council to accept Ms. Nelson-Dodson's resignation.
