Item #13b) Ms. Barbeann Nelson-Dodson requested a review of Committee policy.

7. <u>Update on the Intergovernmental Agreement between the City and the Special Districts</u> – Councilor McAfee

Councilor McAfee stated that the Council recommended that there be a couple of changes to the agreement. She said one would be to make it for only one year. Councilor McAfee also said it was suggested to have a Councilor hold a seat on a District Board. She also said another change is to make sure the City's objectives and goals align with the Water and Sewer District's goal and objectives.

Ms. Barbeann Nelson-Dodson stated that the Board positions are elected positions and also the person has to live within the District's borders. Councilor McAfee stated that the City Attorney will be looking at the pros and cons of all suggested revisions to the agreement from the City.

Chair Scholer suggested maybe having an ex officio member from the Council on the Board that would not be able to vote. Vice Chair Benner also suggested maybe amending the District's by-laws to allow for a Council member to have a seat on the Board.

Ms. Barbeann Nelson-Dodson said that the Districts have not heard anything back from their attorney in regard to a meeting or conversation with the City's attorney on revisions to the agreement.

8. <u>Update on Insurance and Legal Fee costs</u> – Jayne Benner and Councilor McAfee

Vice Chair Benner said she was unable to contact Art Uecker, registered insurance agent for the City of La Pine. She than discussed the request for the insurance policies from the Districts so that Mr. Uecker could make comparisons between them.

Ms. Barbeann Nelson-Dodson then passed out letters from the Sewer District and also the Water District regarding their insurance premiums, etc. Ms. Morgan, Admin Ass't, stated that Chair Scholer had sent her an e-mail requesting that the City obtain copies of the District's insurance policies. Ms. Nelson-Dodson stated that the Special Districts would not waive fees for copying and labor charges which would be approximately \$250 for the Water District's policies alone. She said she did spend several hours of her time compiling the information obtained in the two letters she had just presented. Vice Chair Benner said that this information may not be enough for Mr. Uecker to make comparisons between the various policies. Ms. Nelson-Dodson said the District's would not waive the fees because they thought the request was just from a specific person, Ted Scholer, not the entire committee.

Councilor McAfee requested she ask the Board again about waiving the fees. Ms. Nelson-Dodson said she may be able to just copy the policies and bring them to the committee, herself.

Councilor McAfee stated that she received Council approval for City Attorney Green to start working on a memorandum that will line out all the pros and cons for the absorption. She said as much as we can we can estimate legal fees. Councilor McAfee said it will be presented at a future City Council meeting and then forwarded on to the Special District's attorney for review before it comes back to the utilities committee.

9. <u>Update on Biogreen Purchase of Potable Water from</u>
<u>the La Pine Water District</u> - President Barbeann Nelson-Dodson

Ms. Nelson-Dodson discussed the new offer from Biogreen for Water and Sewer Services. She said they offered \$1 million in cash or a new well and also a new pipe line. Ms. Nelson-Dodson said Biogreen agreed to accept the offer but would prefer the new well and a larger line down the hill rather than the money. She said the District has enough SDC monies to buy the water rights they would need or get a loan for them with very reasonable interest rates. Ms. Nelson-Dodson said the majority of the water for Biogreen will come from the potable water (effluent) produced by the Sewer District. She said they will add a little of the regular water to the potable water for running their boilers.

Ms. Nelson-Dodson said that Biogreen will also pay about \$50,000 a year for services which will mostly go the Sewer District for the potable water usage. She said that Biogreen is looking to save money and they did suggest they could go to Gilchrist if they were unsuccessful with their renegotiations with the Special Districts. Ms. Nelson-Dodson said they have not heard back from Biogreen about the District's request for infrastructure instead of cash monies. She said that Biogreen has indicated they could go over the \$1 million for infrastructure some, but not by several hundreds of thousands of dollars.

Councilor McAfee asked about the new lines in the Master Plan for the Districts. Ms. Nelson-Dodson said that a 14 inch main line is in their future plans. She also said that having another well and pump would be helpful in an emergency situation when a pump went down for example. Ms. Nelson-Dodson said a well would help them service other areas but they are still limited by the gravity flow. She said this will allow them to keep the good flow pressure they have already.

10. <u>Discussion on Water and Sewer Districts Insurance Policies</u>

This item was discussed earlier in the meeting.

Councilor McAfee stated that she did not feel that this Bill really applied to the work of this committee and the City of La Pine. She said it really only related to cities that were currently

in the incorporation process, as well. Councilor McAfee said she asked the City Attorney to review it and he also said it did not apply to La Pine.

12. <u>Chris Marko presentation from RCAC (Rural Community Assistance Corporation)</u>

Chris Marko, RCAC, discussed what his organization does for communities and also how they are organized. Mr. Marko said that he wanted to remind the committee that they are a resource for them and are a nonprofit organization. He said he has been with RCAC for 12-1/2 years, helping move drinking and waste water projects forward.

Chair Scholer stated that he has asked the City to move forward and request these grants and RCAC was one of the organizations that could provide assistance with the grants. He said the committee may be calling on Chris Marko in the future for assistance. Mr. Marko said he is also working with the City regarding economic development planning and discussion. He said they do not believe in coming in and telling a community what to do and prefer to just work with the community to move forward with activities. Mr. Marko said their role could be more than the economic aspect, in response to a question from Councilor McAfee. He said he would like to strengthen their relationship, maybe at the City level so people are aware of us and things we are doing.

Vice Chair Benner asked Mr. Marko about what other types of funding out there he works with for financing other than USDA? He said there are State programs, Community Development Block Grants (CDBG) program, Water and Wastewater Grant/Loan Fund Program and also the Safe Drinking Water Program through Business Oregon, formerly OECDD (Oregon Economic Community Development Department). Mr. Marko said that RCAC has not taken on a lot of management of these grant programs. He said he could help the City apply for the grants but they would probably need some additional resources and those are usually provided for under administrative costs in the grant.
