5. First Street Landscaping and Lighting Design – First Draft

Erik Huffman from Becon Engineering discussed the landscaping for the 1st Street Stop light Project. He said he was working with a landscape architect and an electrician on the design once the road construction is complete. Mr. Huffman also discussed the street lights that will be going in at the site. He said the idea was to have electrical outlets on the trees for holiday lighting. Mr. Huffman said the lighting they would use would be exactly what is at City Hall. The landscaper is working with a local nursery to select plants that will work with La Pine's climate. Mr. Huffman says he has been working with ODOT to have enough conduits for water and power at the site. He said that there will be drainage swells between the curb and the sidewalk.

6. Cagle Road Grading

Scott Perkins, Manager of Public Works, said that Vic Russell graded the Cagle Road. Doug Ward said that the road work looked very good. There was a discussion on the fact that Skidgel Road is really tore up even right after the grading. Mr. Perkins said there was not much that could be done with it this late in the year.

7. Sidewalk Repair – Mac Court

Scott Perkins said that Vic Russell has repaired the damage to the sidewalks on Mac Court. Doug Ward said the property owners were happy with it.

<u>8.</u> Water and Sewer Rate Study Update

Scott Perkins said that staff has been meeting with the company that is doing the water/rate study for the City. Ms. Williams said that there will be changes in the way the rates are set and also that the cost will probably change. She said they will probably be using meter sizes as a way of determining cost. Mr. Perkins said they are discussing where they should start the base charge. He said what determines if you need a bigger meter is the plumbing code like if you have five bathrooms in a building. Mr. Perkins says the meters cost \$250.00. He said the electronic registers have a guaranteed life span of ten years and that the meters will last a long time, more than ten years.

Mr. Perkins said that they are considering basing the sewer rate for residential on a flat charge plus monthly charge per 1,000 gallons of water based off the winter usage. He said the commercial rate will probably be based on however many gallons of water was used that month.

9. Other Issues/Concerns

Doug Ward asked where the Senior Center property begins with the new sidewalk, on the west side of the sidewalk or on the east side of the sidewalk? Mr. Perkins said he did not know. Chair Weller said he thought the border was at the center of the street, but was not sure. Mr. Perkins said a map would show the approximate property line. Ms. Williams said she could probably get that information from the DIAL system for Deschutes County. There was also a discussion on who's responsibility it would be for snow shoveling the sidewalks.

There was also a discussion on the South County Advisory Committee. Linda Johnston said they have done a lot with the septic issue. It was stated that the septic issue is still not resolved. There was also a comment about setting the speed limit on Evergreen. It is considered a private drive with no outlet and that is how it is considered by the City. There was a discussion on forming their own road district and setting their own speed limit. Chair Ward said that 25 mph is the lowest speed that the State of Oregon recognizes for residential zones.
