5. Booster Station – Background and Current Status

Public Works Manager, Jake Obrist, stated that there is a public works booster station that is set up on Hinkle and Williams Foss. He said it has a 250,000 gallon capacity. It performs back-up storage and extra pressure for the system.

Utility Worker Mike Ward said the City operates with two wells, two reservoirs and a booster pump station. One of the reservoirs on Finley Butte is really the only one that can be utilized. Mr. Obrist said the booster station that is not

working has not worked for several years. He said a month ago they started using that unused booster station, again. It consists of four booster pumps. He said they would like to have two of the booster pumps working all the time and keeping pressure up in the system as needed and recycle water, also. Emergency mode would be able to use all four pumps such as if there was a fire. However, it would not be good for the system if it is used in normal mode. There was also a discussion on a maintenance cycle done on a periodic basis.

6. Update Status of Wickiup Lift Station Project

Mr. Obrist said they hope to have the new lift station operational in the very near future. This should resolve the old system from backing up as it has done from time to time.

7. 1st Street Improvements – Benches and Garbage Cans

Mr. Obrist discussed that the public wanted some benches and garbage cans along 1st Street. He said the selection of materials will be uniform, in design, for the City. Mr. Obrist said the benches and garbage cans were expensive. He said some of them have a fifty year guarantee. He also suggested having covers on the garbage cans because of snow.

8. Wastewater Treatment Operator Certification Update

Mr. Obrist said he had three certifications but did not have his treatment license when he became Public Works Manager. He said he just passed his Treatment II certification last month. Mr. Obrist said Mike Ward, Utility Worker, will also be going for a treatment license.

9. Safety Walk Through

Mr. Obrist said they had a mock OSHA walkthrough done by the insurance company. He provided a check-off list so the City could work on it over the year. Mr. Obrist said they have a safety meeting every month.

10. Other Issues/Concerns

Mr. Obrist said he has a concern about the septage amount they take in each month. He said it almost exceeds the allowable limit each month. He said he would like to stop allowing some Bend septic companies to empty their septage. There was a discussion of having a new septic receiver station in about a year. It was also discussed that raising the rates, especially for out of area, may be a way to resolve the issue. The committee had consensus to raise the rates.

A motion was made by Russ Smith and seconded by Tom Weller to approve increasing the rates to septage companies that are out of the area.
