# 5. Interview Candidate for Public Works Committee

Jayne Benner, candidate for the Public Works Committee gave a brief history of her work and activities with the City of La Pine. She said she was on the political action committee to get the City incorporated. Ms. Benner stated that she also worked on economic development after the City was incorporated. She said she was impressed at how much the City had developed over the past ten years. Ms. Benner also worked on the first budget for the City. Mr. Misley said the term for this position would expire December 31, 2017.

A motion was made by Russ Smith and seconded by Jim Fleming to Recommend Jayne Benner for appointment to the Public Works Committee. ### 6. Wastewater/Water Expansion Project Open House

Mr. Obrist discussed the Open House that will be held at the La Pine Community Center on November 15, 2016. It will be to inform the public about the water/wastewater expansion of service to the Cagle and Glenwood neighborhoods. He said staff from the City will be there to answer questions and provide information. Mr. Misley discussed the funding opportunities for the expansion. He said these improvements will set up the City for the next decades.

### 7. Update on Septage Receiving Rates

Jake Obrist discussed the plan to raise the septage rates due to over capacity of the septage system. He said they were considering charging a higher rate for septage that is brought in from out of the local area. The local area would be Sunriver and La Pine. The local area will be charged less then out of area but still pay a higher rate than before. Mr. Obrist said the City is also working on making improvements to the current septage system.

## 8. Update on Wickiup Lift Station

Mr. Obrist said the project has been taking a lot of time to complete but progress is ongoing. He said he hopes the project will be completed by the end of October.

#### 9. Central Oregon Public Works Partnership (COPWP) Agreement

Mr. Obrist stated that, in case of an emergency, the City needs to join the COPWP. This would provide technical and staff assistance in case of an emergency like a hydrant getting hit by a car and City water having to be temporarily shut off. It was decided to put the agreement before the City Council at the November15th City Council meeting.

A motion was made by Russ Smith and seconded by Jim Fleming to recommend for approval the Central Oregon Public Works Partnership Agreement.
