## 1. Call to Order

# 2. Establish Quorum

#### 4. Approval of November 14, 2017 Meeting Minutes

Russ stated that he wants the old format back of how meeting minutes used to be done with regard to voting and staff attendance. The rest of the committee felt that the current format was fine "as is" or did not share an opinion. *Tom Weller made a motion to approve the November 14, 2017 meeting minutes as written. Jayne Benner seconded. No objections. Unanimously approved.* 

## 5. Telemetry Staff Report and Proposal

Jake Obrist provided a staff report explaining telemetry. This will allow the City to monitor our systems at all times. There was discussion on how much the City has spent thus far responding to emergencies. The estimate for the system is \$18,000. Wayne asked if we'd be able to upgrade as time went on and Jake said yes. *Tom Weller made a motion to recommend the system to the Council for purchase.*Wayne Barth seconded. No objections. Unanimously approved.

## 6. Low Income Utility Assistance Staff Report

Jake Obrist and Ashley Williams presented a staff report on low income billing and delinquent accounts. There were different options with regard to the rate of discount. Wayne said that he would like 50% and 25%. Tom said that the scales could slide both ways. Russ said 60% and 25%. Jayne said that she favored 50%. There will be additional information and discussion to follow.

# 7. Public Works Advisory Committee Meeting Schedule for 2018

Jake Obrist explained that some committee members had approached him regarding meeting on a monthly basis and wondered if it was actually necessary. He also pointed out that the committee is only required to meet quarterly. Wayne said he would rather meet every other month than quarterly. Russ feels the committee should be meeting monthly. Linda thinks it is asking too much for the staff to meet monthly. Tom doesn't think it's necessary to meet every month. Jim said that every other month is ideal for him. *Tom Weller made a motion to meet every other month. Wayne Barth seconded. No objection. Unanimously approved.* 

## 8. Other Issues/Concerns

Jayne and Wayne would like to be re-appointed to the committee. Russ Smith nominated Wayne Barth to be Chair and Jayne Benner to be Vice-Chair. Tom Weller seconded. No objections. Unanimously approved.

Dave Culp asked Jake if the City could get some speed signs on Drafter Rd. Jake stated that we could put a speed trailer there and that the City was looking at budgeting for dust abatement there as well.
