5. Various ODOT Projects - Oregon Dept of Transportation

Mr. Mike Darling and Gary Farnsworth, from ODOT, discussed the various projects. They discussed the re-paving project from Sunriver to Hwy 31. Mr. Farnsworth discussed the one million dollar monies that are directed for the curb-gutter sidewalk project in downtown La Pine along Highway 97. The sidewalks also needed to meet ADA (Americans with Disabilities Act) requirements. Utilities may need to be moved in the construction of the sidewalks. There was a discussion of how much work on the sidewalk project could be done given the funding available. Mr. Allen discussed the amount of right-of-way available for the project. Mayor Mulenex stated he liked the idea of going as far as possible with the money and to cover as much ground as possible and maybe put off some of the landscaping and lights. Mr. Allen said the sidewalk needs to at least be between 1st Street and Huntington. Councilor Agan agreed with that proposal. There was also a discussion on the 1st street stop light project in La Pine. He said the opening has been moved to late October due to additional bidding by contractors. There was a report on the Wickiup overpass project. ODOT said everything was going well with the future project.

There was a discussion about working with the property owners in regard to issues that might arise with the sidewalk project. There was also a discussion on the re-paving project and how that may affect the property owners along Hwy 97.
