#### 5. Discussion on Snow Removal

Interim City Manager Rick Allen stated it was a tough couple of weeks for City staff. He said going down to just one contractor made it more difficult as the new snow plowers did not know the route. Mr. Allen said the heavy snow was also an issue. He said power lines came down because of the heavy snow. Mr. Allen said that vehicles parked where the snow is supposed to go was another problem, especially in Huntington Meadows. Cory Misley stated that staff put notices on cars and doors on Shawpine and Huntington Meadows requesting residents to move their vehicles out of the bio-swells where the snow needed to go and out of the public right-of-way. Cars that had not moved were towed at

owner's expense. Mr. Misley said that the City needed a strategy for which roads get plowed first for traffic issues. He said there is now a snow removal page on the website that states what the City does and does not do. Mr. Misley said there are now priority 1 roads and priority 2 roads. All of these things will make the snow removal better for the City residents. He said staff is also working on an Ordinance for snow removal. There was a discussion on putting something in the local newspaper regarding the vehicles parked in bio-swells and also other snow related issues. Mr. Allen also discussed the help the City received from Deschutes County with snow plowing.

## 6. Review Draft Sidewalk Ordinance

Mr. Allen said that the businesses need to take care of the lawn or sidewalks in front of their businesses. He said that this request is normal. If the businesses do not mow their lawns, the City will do it and charge the business for the cost. Mr. Allen said the ordinance also addresses snow removal on the sidewalks. He said the sidewalk ordinance will apply to residential areas as well.

## 7. Update on 1st Street & Hwy 97 Landscaping Project

Mr. Misley passed out the landscaping plans for the project. Eric Huffman, Becon Engineering, discussed the plan. He said there would be irrigation included and electrical outlets at each tree for Christmas lights. There was a discussion on the amount of trees and shrubs that will be planted for the project. Completion of landscaping should be before Memorial Day. There is a limited guarantee on the life of the trees and shrubs.

## 9. Other Issues/Concerns

Mr. Allen discussed the development plans for Huntington Meadows, especially addressing snow removal and off street parking. There was also a discussion on the problem with some wells going dry in the Cagle neighborhood. Chair Johnston said that they are having to drill new wells at some of the lots.

Mr. Misley stated that on February 23<sup>rd</sup> at Rosland Elementary School there will be an Open House from 5:30 to 7 pm. The topic will be on the water and waste water expansion into the Cagle Neighborhood. Mr. Allen said that the Cagle neighborhood will have to hook-up to sewer and water, it will not be voluntary. He also said that because the roads will be dug up for the project, it will be possible to make the roads wider. Mr. Allen said a new well will be put in place for the Cagle expansion project.

## 10. Public Comments

Mayor Mulenex stated that Glenwood Acres went on City water because of wells that experienced caving-in. He said they did not have a way to re-drill the wells. Mayor Mulenex said that landscapers need to be careful about the type of trees they put in, many varieties will not make it in La Pine. He also discussed that there will be various ways customer's can receive help with the cost of hooking up in the Cagle neighborhood. There was also a discussion on the nitrate problem and the unfortunate perception that La Pine has bad water.

#### 11. Staff General Comments

Mr. Allen said there will not be a Public Works Committee meeting in February. Mr. Misley said there will be another Open House on March 3<sup>rd</sup> from 4:30 to 6:30 pm at City Hall. This Open House will address the US 97 & Wickiup Junction Project, US 97 Romaine Village to Lava Butte, the re-paving on Hwy 97, US 97 Sunriver to Forest Boundary Project and the sidewalk project in La Pine. He said ODOT will be sending a notice about the Open House to all the 97739 zipcode residents.

## 12. Committee Member General Comments

Mr. Perkins said that tonight, January 12<sup>th</sup>, from 11 pm to 5 am the water will be turned off for residents by Wickiup Junction because of the moving of utilities for the project there. There was a discussion of Gordy's getting rid of their water tank. There was also a discussion about owners wanting to split lots (subdivide) in the Cagle neighborhood because of the water and sewer going in there.
