## e. Council Deliberations [no vote] [Budget to be adopted June 12, 2013 Regular Council Meeting]

Mayor Mulenex discussed the youth employment program that was in last year's budget. He said he has taken the program to Park and Rec and they are willing to do it. Mayor Mulenex said they would set up the program and manage it for a fee. He said this program is necessary because of the lack of employment opportunities for young people that exist in the City.

Interim City Manager Allen said that there is no miscellaneous fund to take the money out of at this time. Councilor Martinez said he liked the concept of student employment but he did not feel comfortable in changing the budget at this point in time. Councilor Martinez said that Park and Rec should take the lead on a program like this with the City as a follow-up. Interim City Manager Allen said that the monies would have to be taken out of a specific budget item to do the program now.

Councilor Ward stated that there could be issues with insurance for the program. Interim City Manager Allen said he did not see this program getting off the ground with a young person employed this year. He also said that Park and Rec does not have the staff to do a program like this at the present time. Mayor Mulenex said that the program needs to have structure around it and could be something worked on over the next year. Councilor Martinez stated that the Crescent Ranger District has a program for employing youth and that maybe they could manage the program for La Pine.

Councilor Ward said that she would like to see a line item specifically for the Frontier Days and the La Pine rodeo because they bring so much business into the City. Mayor Mulenex said that they would need to be sure that money given to them was managed properly. Interim City Manager Allen said that they could ask to see a copy of their tax return. It was discussed to have a meeting regarding this matter at a later point in time.

Mr. Ward also congratulated the Mayor on the successful clean-up day for the City.

#### 8. Staff Comment

Interim City Manager Allen stated that the Public Works Committee will be reviewing a number of projects when they meet next week. He said he also met with Tom Weller at Midstate regarding the lighting project. Interim City Manager Allen stated that the cost for the lighting will actually be much less than was previously thought because of a credit for the lights. He said Finley Butte would be getting some lighting for that street, as well as the Crescent Creek Neighborhood.

### 9. Mayor and Council Comments

Mayor Mulenex stated that he had talked with County Commissioner Tammy Baney and Alana from COVA (Central Oregon Visitors Association) and they have offered to come to a council meeting and discuss how TRT funds are utilized in the State of Oregon. Interim City Manager Allen stated that the meeting should happen sometime in the fall after the tourist season.
