

RESOLUTION NO. 2016-22

A RESOLUTION OF THE CITY OF LA PINE DESIGNATING CERTAIN STREETS AS SNOW ROUTES FOR CITY'S SNOW REMOVAL OPERATIONS.

WHEREAS, the City of La Pine ("City") has general responsibility for the maintenance of streets within City's incorporated limits; and

WHEREAS, the control and removal of snow and ice from City streets is a maintenance function and is necessary to provide safe movement of emergency vehicles, permit safe operation of school busses, and facilitate the movement of people, goods, and services throughout City; and

WHEREAS, vehicles stopped, stalled, and/or parked on City streets during snow and/or ice removal operations constitute hazards to vehicular traffic, present risks to emergency vehicles, and inhibit snow and ice removal operations; and

WHEREAS, on November 16, 2016, City adopted Ordinance No. 2016-11 (the "Snow Removal Ordinance") to establish a policy concerning the control of snow and ice on, and removal of snow and ice from, City streets; and

WHEREAS, Section 5.1 of the Snow Removal Ordinance provides that the La Pine City Council (the "Council") may, by resolution, (a) designate certain streets in City as snow routes for snow removal operations, and (b) assign such routes as primary and secondary priority streets according to the level of service necessary for each street.

NOW, THEREFORE, the City of La Pine resolves as follows:

1. Findings. The above-stated findings contained in this Resolution No. 2016-22 (this "Resolution") are hereby adopted.
2. Primary Snow Removal Routes. The following streets are hereby declared to be primary snow removal routes:
 - (1) William Foss Road from US 97 to Mitts Way
 - (2) 4th Street from US 97 to Morson Street
 - (3) Evans Way from William Foss Road to terminus
 - (4) Hinkle Way from Reed Road to Finley Butte Road
 - (5) Wheeler Road from William Foss Road to terminus
 - (6) Mitts Way from Reed Road to CW Reeves Lane
 - (7) Bonnie Way from William Foss Road to Finley Butte Road
 - (8) Preble Way from Finley Butte Road to Bassett Drive

- (9) Morson Street from 1st Street to US 97
- (10) 1st Street from Huntington Road to east terminus
- (11) Bluewood Avenue from 1st Street to Bluewood Place
- (12) Caldwell Drive from Huntington Road to Crescent Creek Drive
- (13) Crescent Creek Drive from Caldwell Drive to Findley Drive
- (14) Findley Drive from Huntington Road to Crescent Creek Drive
- (15) Cagle Road from Huntington Road to Murray Drive
- (16) Skidgel Road from Burgess Road to Cagle Road
- (17) Drafter Road from Rosland Road to US 97

3. Secondary Snow Removal Routes. The following streets are hereby declared to be secondary snow removal routes:

- (1) Murray Drive from Cagle Road to terminus
- (2) Santa Barbara Drive from Cagle Road to terminus
- (3) Elm Drive from Cagle Road to terminus
- (4) Oak Drive from Cagle Road to terminus
- (5) Ash Drive from Cagle Road to terminus
- (6) Railroad Street from Burgess Road to Cagle Road
- (7) Antler Lane from Burgess Road to Cagle Road
- (8) Doe Lane from Burgess Road to Cagle Road
- (9) Pine Drive from Burgess Road to Cagle Road
- (10) Pine Place from Huntington Road to terminus
- (11) Glenwood Drive from Burgess Road to Huntington Road
- (12) Allen Drive from Glenwood Drive to Glenwood Drive
- (13) Trapper George Lane from Fordham Drive to Fordham Drive
- (14) Fordham Drive from Caldwell Drive to Beesley Place

- (15) Charlotte Day Drive from Fordham Drive to Crescent Creek Drive
- (16) Beesley Place from Findley Drive to Crescent Creek Drive
- (17) Memorial Lane from Huntington Road to east terminus
- (18) Victory Way from Huntington Road to east terminus
- (19) Stillwell Street from 1st Street to Morson Street
- (20) 2nd Street from Morson Street to Stillwell Street
- (21) Walker Street from 3rd Street to 5th Street
- (22) 5th Street from Walker Street to Pengra Street
- (23) Pengra Street from 6th Street to 5th Street
- (24) Carter Court from Preble Way to terminus
- (25) Heath Drive from Huntington Road to east terminus
- (26) Cassidy Court from Preble Way to west terminus
- (27) Cassidy Drive from Preble Way to east terminus
- (28) Riley Drive from Huntington Road to east terminus
- (29) Betty Court from Preble Way to west terminus
- (30) Betty Drive from Preble Way to east terminus
- (31) Bassett Drive from Huntington Road to east terminus
- (32) Assembly Way from Hinkle Way to Mitts Way
- (33) Box Way from Hinkle Way to Mitts Way
- (34) Dillon Way from Hinkle Way to Mitts Way
- (35) Ascha Court from Hinkle Way to east terminus
- (36) Mac Court from Wheeler Road to north/south termini
- (37) Wyatt Drive from Wheeler Road to Mitts Way
- (38) Lasso Lane from Wheeler Road to Wyatt Drive

- (39) McClintock Place from Wheeler Road to east terminus
- (40) Oakridge Place from Mitts Way to west terminus
- (41) Shaw Pine Court from Mitts Way to west terminus
- (42) Apache Tears Court from Wheeler Road to south terminus
- (43) Cabin Lake Lane from Wheeler Road to east terminus
- (44) Salzer Street from 1st Street to terminus

4. Parking Prohibited on Primary and Secondary Routes. Pursuant to Section 5.2 of the Snow Removal Ordinance, parking is prohibited along primary and secondary snow removal routes whenever accumulation of snow reaches four inches (4") or more. Vehicles parked along primary and secondary snow removal routes in violation of the Snow Removal Ordinance may be removed at the owner's expense. City will not be liable for damage to vehicles parked in violation of the Snow Removal Ordinance.

5. Snow Removal Routes Map. A map of primary and secondary snow removal routes is available for public review at La Pine City Hall, 16345 Sixth Street, La Pine, Oregon.

6. Miscellaneous. The provisions of this Resolution are severable. If any section, subsection, sentence, clause, and/or portion of this Resolution is for any reason held invalid, unenforceable, and/or unconstitutional, such invalid, unenforceable, and/or unconstitutional section, subsection, sentence, clause, and/or portion will (a) yield to a construction permitting enforcement to the maximum extent permitted by applicable law, and (b) not affect the validity, enforceability, and/or constitutionality of the remaining portion of this Resolution.
