1. Call to Order

Councilor Agan led the Pledge of Allegiance.

4. Ordinance 2012-05

An Ordinance adopting modifications to the Comprehensive Plan, Zoning Map, Zoning Ordinance, and Sign Code; and, Declaring an Emergency.

i. Open Public Hearing

Councilor Greiner opened the Hearing.

ii. Staff Report

Deborah McMahon, Land Use Consultant, stated that last year they received partial approvement of the comprehensive plan. She said she has only received comments on the sign code but not the other zoning codes. Ms. McMahon said that with regard to codes, only the sign code with revisions would be reviewed. She said that the comprehensive map has been revised to have an applied public facilities zone.

Ms. McMahon stated that the first change was to add some policies and programs for the riparian area and also require a wet land inventory be done. She said that until a TSP (Transportation System Plan) is done the City will have to utilize the County's zoning. (The City is in the process of completing a TSP).

Ms. McMahon stated that the biggest problem that the State had was with the UGB (Urban Growth Boundary). She said she feels that the work that was done on this matter would be eventually successful and not hamper the comprehensive plan from being approved. Ms. McMahon stated that the City has excess lands of between 900 and 1,000 acres. She said that for every item contested by DLCD (Dept of Land Conservation & Development) she has written a cover letter for it.

Ms. McMahon said every two years the comprehensive plan needs to be reviewed and data added to it as it becomes available. She said there were not many changes required for the zoning ordinance.

iii. Public Comment

Robin Mirrasoul, area resident and sign business owner, discussed the letter she had sent to the Council and some of the staff regarding concerns she had about the sign ordinance. Renee Kapp, area resident and sign business owner, stated that she supported the sign code being reduced to just a few pages. She said she would prefer to see one sign per building.

City Manager Hasson gave a review of the budget calendar and also the changes that the 2012-2013 budget contains. He said the new budget will be adopted at the June 13th Council Meeting. Mayor Mulenex stated that the process of putting the budget together went very smoothly.

iv. Resolution No. 2012-04 State Shared Revenue ORS 221.760

Mayor Mulenex stated that either the Chamber or the Park & Rec District would run the youth jobs program contained in the budget. He also said that the City has total oversight of the funds in the budget. City Manager Hasson also said that the City will monitor this program and require accountability from the organization disbursing the funds. City Recorder Martin discussed a small change on LB 30, line 2, under the approved by budget committee for the Sewer Districts. She said the \$41,900 is different than what it was before and they took it away from line 35, they just switched it up, so there would be more payroll taxes because it had been \$11,900 and was changed to \$41,900.

City Recorder Martin stated that on line 35 under general operating contingencies it had been reported as \$300,000 it is now \$270,000.

He said under section one of the Resolution the ORS number was incorrect but has been corrected. Under section one it was titled ORS 323.4555 and they struck one of the 5's so it would be ORS 323.455. City Manager Hasson stated that under number three it should say, regarding storm sewers, that it should read one or more utility services. These changes have been made.

10 Consideration and possible approval of Mosquito Abatement Contract

City Manager Hasson stated that the City received two proposals for the mosquito abatement. He said he sent the Council an e-mail regarding the proposals. City Manager Hasson stated he spent quite a bit of time reviewing them both. He said both companies had all the insurance and permits necessary to provide the services. City Manager Hasson said after reviewing both proposals he recommended Terminix receive the contract. He said it is really important to provide a consistent type of service and Terminix would spray all the streets on a weekly basis as needed. Councilor Varcoe stated that he favored doing a lot of spraying in June so there would be very few mosquitos for the Rodeo and Frontier Days over the 4th of July.

Representatives from both companies were present and discussed their abatement proposals.

Public Comment

Commissioner Doug Ward asked about interrupted spraying that he observed last year. The representative from Terminix said it can involve a wind issue or very high heat that takes the product off where it is supposed to be. He said the tech came back to the area later in the day to spray the areas not sprayed originally.

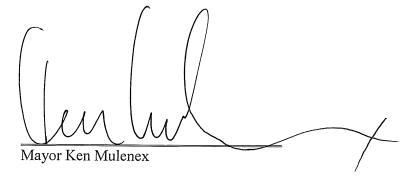
