## La Pine City Council Workshop May 30, 2007

#### A. Call to order: 6:55 PM

Roll call: Mayor Martinez, Councilor Shields, Councilor Damerval, Consultant Jo Anne Sutherland, Recorder Fleming –Councilor Daggett absent – Councilor Jordt absent Quorum **established**. Councilor Daggett arrived 6:59

## 1. Economic Revitalization Team meeting June 7th

Jo Anne Sutherland said she had been contacted by Janet Brown on behalf of Governor Kulongoski and was told the team's June meeting would be held in La Pine. Jo Anne explained the team is made up of 10 different federal & state agencies. The team is asking for input, ideas and a list of questions and concerns from the City of La Pine for discussion at the meeting. Items listed concerned planning, possible grants and technical assistance. The council also has many questions about city authority, municipal codes, ordinances and charging SDC's. They would also like information from ODOT about streets/traffic signals and funds that might be available for downtown beautification. The council also has questions about advertising the Industrial Park land, DEQ/city enforcement and responsibility for hazmat cleanup. Information on state funding for low income housing will also be requested. Other items may include questions on BLM lands, urban growth boundaries and land use. Jo Anne said that Deschutes County is also asking for a meeting and that will be a workshop on June 25th in La Pine at 6:45 PM. Some of these issues will be discussed again then.

# 2. Governor's Office Rural Policy needs and issues meeting

Jo Anne informed the council the Governor's office had requested the City Council attend a meeting to be held June 6 at 1:00 PM in Redmond. Jo Anne is working on items for the agenda including questions on low income housing, BLM lands, DEQ and the Newberry Industrial Park

#### 3. Review Ordinances

**a.** Ordinance No. 2007-3 Solid Waste Management Ordinance Mayor Martinez left and went outside during this discussion to avoid any possible conflict of interest.

### b. Ordinance No. 2007-4 Business License Ordinance

Councilor Shields expressed concern that this has not been talked about before, therefore no decision has even been made to <u>establish</u> a business license fee, and we need to do that before adopting an ordinance.

Both ordinances will be read twice by title only at the June 13th City Council Meeting.

#### 4. Review Resolution

#### a. Fee Schedule

It was noted that "Itinerant merchant" was listed on the fee schedule, but not in definitions. The term was changed to "Transient Merchant," and will be added to the definitions. The Transfer fee was increased to \$25.00 and non-profits and event based vendors would be exempt. A meeting will be scheduled with the Chamber of Commerce to review and ask for suggestions. This will be discussed again at the June 11 workshop and plan to present at regular meeting on June 13<sup>th</sup>

## b. Local Government Investment Pool

Jo Anne suggested any collected funds for the city could go into the Government investment pool in order to collect better interest. They would provide accounts services and reports for free.

#### 3. Surplus Resolution
