**Resolution 2007-012** Adoption of Deschutes Co. 2007-2008 Fee Schedule. After a brief explanation and a reading of this resolution, a motion was made by Councilor Daggett to adopt this resolution. It was seconded by Councilor Jordt. All ayes motion passed.

#### 9 Council comments

Councilor Jordt reported that a citizen had a complaint about one of his neighbors. The complainant is requesting a letter be sent to the abuser from the city. Discussion about the issue ended with the council concluding there is no immediate solution to this, as the city is still in the formation stages and therefore has no ordinance in place to cover this. There will be further discussion at the next work session. A letter will be composed to the complainer, stating we had received his complaint, just for the record.

Councilor Jordt reported she had a meeting with ODOT regarding the small cities grant. It was suggested to her that the Cagle subdivision be a first priority on road maintenance and repair. ODOT will submit a proposed cost.

The street lights were discussed briefly. Recorder Damerval reported the city had their first wedding at City Hall. Councilor Jordt hadn't called the attorney yet for an IGA with the Chamber and Park & Rec. Also, a letter for procedure to change signers on bank account was discussed, and needed to be signed by all councilors. A letter was emailed to councilors from the Library, asking to be linked to our web site. All agreed to have that done.

## 10 Additional public comments

Rose Alsbury - Commented that the IGA for the Chamber should be an MOU, as it is not a government, but a private non-profit agency.

<u>John Taylor</u> - Commented that a noise ordinance usually comes with a comprehensive plan. The County is starting transportation safety programs. Wickiup Junction ride share area clean up plan was implemented. Asked about a representative for COCIB grant commission.

# 11 Adjourn

A motion was made by Councilor Daggett to adjourn, and was seconded by Councilor Jordt. All ayes - meeting adjourned at 7:51 p.m.
