Judy Keller and Linda Reid made a presentation to the Council for the Ford Co Hort 4 project of building public restrooms in Heritage Park. These would be the only public restroom facilities in La Pine. They were asking for \$2,000.00. Interim City Manager Allen stated that it was early in the process to fund additional monies for the restrooms. (\$2,000 was already awarded to them out of next year's budget.) Mr. Allen suggested that the Co Hort come back further in the process to request additional monies at that time. Mayor Mulenex stated that he favored waiting till the process is further down the road and then come back and request additional funding.

11. Recognition of Conrad Parker

- FBLA (Future Business Leaders of America) State Competition

Councilor Martinez stated that Student Councilor Parker has contributed to the City projects. He said he is also very involved in various sports and civic organizations in High School. Councilor Martinez presented Conrad Parker with a framed certificate of achievement.

Glen Costello gave a presentation against the moratorium on medical marijuana dispensaries in La Pine. He said it is time to stop treating marijuana as a bad thing. Mr. Costello said that in Colorado crime has actually decreased since legalizing marijuana. He cited various examples of people that were helped with medical marijuana.

Mr. Costello also discussed the people that are having to purchase expensive septic systems and if the problem could be avoided if they could be on sewer in the City. Interim City Manager Allen said that the State is working on legislation to allow sewer systems outside of urban growth boundaries.

Interim City Manager Allen discussed the Land Transfer Agreement. He said the library sits on the land that has already been deeded to the City. Mr. Allen said that the new skate park will sit on part of the land.
