- 7. <u>Hearing on Ordinance No. 2014-06 An Ordinance Making Certain Determinations and Findings Relating to and Approving the La Pine Urban Renewal Plan</u>
 - a. Open Hearing

Mayor Mulenex opened the Public Hearing.

b. Staff Report

Elaine Howard, Urban Renewal Consultant, gave the staff report. She briefly reviewed the history of urban renewal in La Pine. She discussed the advisory committee that met to discuss urban renewal over the winter and spring. Ms. Howard said on June 16th the Urban Renewal Agency was enacted for the City of La Pine. She said formal letters were sent out to Taxing Jurisdictions notifying them of urban renewal for La Pine. Ms. Howard said that a formal notice was sent to the residents regarding tonight's hearing. She said that the Deschutes County Board of County Commissioners will also vote on the Urban Renewal (on August 4th) because some of the urban renewal area is outside the City limits. Ms. Howard discussed how the boundary for urban renewal in La Pine was selected. She said there are two guidelines on urban renewal, one of them is regarding assessed value. Ms. Howard said the other guideline is acreage. La Pine met both guidelines. She said there has been quite a bit of public involvement during the urban renewal process. Ms. Howard reviewed the goals and objectives of the urban renewal plan.

She also discussed store front loans and grants to improve businesses appearance. Ms. Howard said the City could partner with a developer to develop an area by perhaps providing the infrastructure for a development. She said they projected a conservative 4% growth rate over the next twenty-five years. The maximum indebtedness is the controlling feature of urban renewal. It controls how long an urban renewal plan goes for and also how much money can be used for urban renewal. The maximum indebtedness for La Pine's urban renewal is \$7,000,017. Ms. Howard said that eventually all taxing jurisdictions should receive more income as the property values increase as a result of urban renewal. Ms. Howard discussed the letter that was received from the La Pine Fire District. She said the City is in the process of answering the questions posed in the letter and will respond soon.

c. Public Comment

Larry Pearce, area resident, complained about the fact that there are no signs identifying the Industrial Park in La Pine. He said that urban renewal should look at signage for the Industrial Park. Al Zupo, area resident, stated he was concerned about the monies that were being cut from the Sheriff's Department and Fire Department. He said he was concerned about the level of service being affected. Mr. Zupo also wondered about the tax collections if there is another housing crisis like what happened in 2009. He also said that all the taxpayers of Oregon are funding urban renewal, in his opinion. Jerry Hubbard, area resident and member of the Fire District Board spoke. He stated that he opposes tax increment funding but is in favor of La Pine improving the City. Mr. Hubbard reviewed the cost associated with operating the Fire District. He said the annual rate of the \$39,000 tax increment amount would adversely affect the Fire District.

Interim City Manager Rick Allen joined the meeting through skype at 6:45 pm.

Ron Miller, area resident, stated that he is a strong advocate for urban renewal. He also said he is a developer. Mr. Miller said that the region is looking at La Pine and that urban renewal is a tool. He said the data on urban renewal is sound. Mr. Miller said it is an investment in the City. Doug Cox, area resident, stated that he is with the La Pine Fire District. He said he wondered why the City did not go out to the people and ask for money like the Fire District does. Chief Supkis, Fire Chief, stated that the Fire District supports thriving communities. He said it is the funding plan and the taxpayer's trust that is at the issue. Chief Supkis said it has already been detailed of the adverse effect the additional tax will have on fire department services. He then discussed the possible difference that may occur to services as a result of the tax. Dan Varcoe, area resident, stated that we need to take care of the City. He said that the City has not been able to afford what needs to be maintained in the City. He also said we can do whatever it takes to keep the fire department viable. Glen Costello, area resident, asked about the development that will occur. Elaine Howard stated that the Urban Renewal Agency Board will work with the businesses to do projects. She said it will be several years before anything big can be done. Mr. Costello stated that the urban renewal he has experienced did not work on the infrastructure for developments.

Billing Utility Specialist Ashley Williams read a letter from Rich Priday, of Madras, in support of urban renewal.

Linda Reid, area resident, stated that the town is tired looking and really has not changed much and does need help.

Mayor Mulenex said he was proud to see so many people at tonight's meeting. He said he respects and is proud of the fire department.
