#### 6. Public Comments

Dennis Scott, area resident, asked about the grading of the roads in the Cagle neighborhood. He also said he wanted to thank the City for putting the barricades up at the end of Cagle Road. Interim City Manager Rick Allen said grading has been done four times in the past year. He said money has been set aside to do widening on Cagle Road and also putting in eight inches of base rock and raising it. Mr. Scott also asked about when the public meetings would occur regarding extending sewer and water into the Cagle neighborhood. Mr. Allen said they will occur once the consultants have finished their research and report.

Jim Fleming, Public Works Committee member, mentioned that on February 17<sup>th</sup> there will be a discussion on sewer and water rates at City Hall.

#### 7. Presentation by Lodge Pole Dodgers Snowmobile Club

Ron Pugh, area resident, stated the convention was very successful and he thanked the City for its support. He said 220 people attended the convention. Presentation on Ford Foundation Grant: Mr. Allen said the City's cost involved with the grant would be very minimal. Kathy Debone and Dan Varcoe gave a PowerPoint presentation about the grant. Mr. Varcoe said it is a proposal for a team from RDI (Rural Development Initiative) to come and do some work in the community of La Pine. They would engage the leadership in ways to move forward economically. It will also address sustainability for economic development. Mr. Varcoe and Kathy Debone discussed the various community goals that have already been accomplished. It is a \$26,000 project to do an assessment and action plan. \$2,000 will come from the City and probably some legal

fees as well. Kathy and Dan have volunteered to do the public relations part of the grant work. They hope to have the first part of the project done by the end of May, 2015. Then they will work on the sustainability part of it. Councilor Ward said she is glad to see the relationship with the Ford Foundation, continuing. Councilor Agan and Jones also agreed with Councilor Ward. Mayor Mulenex praised the work that has already been done in the City because of the Ford Foundation. He also said it is a great way for the City to contribute to the community.

Mr. Allen said there are two positions on the Budget Committee currently available. He also discussed the meeting he had with various public entities regarding the remodeling of a home on Huntington. Scott Perkins said Mike Ward, Public Works employee, is applying for various utility certificates and also he and Johnny Bales will be getting their Class A CDL. It was announced that Mr. Perkins recently received a performance evaluation and raise.

#### 17. Council Comments

Councilor Agan said she would like information on business licenses. Mr. Allen said he would look into getting something that would show new businesses or how many businesses have applied for a business license. Councilor Jones said he attended the League of Oregon Small Cities informational meeting. He said they encouraged everyone who votes on utility rate increases to call the Ethics Board before voting on an increase. This is because most of the Councilors are customers, as well. Councilor Jones said he would get the Ethics Board phone number and send it to the Councilors. Councilor Ward said she attended the Park & Rec Board Meeting and they have decided not to do a levy. There was also a discussion on the moving of the Skate Park to the permanent location. It looks at this time like it would be very expensive to build when all factors are taken into account. Councilor Jones asked that a street light over the new bathroom in Heritage Park be installed.

# 18. Mayor's Comments

Mayor Mulenex said there is a Vetal meeting at the Bend Fire Station on Feb. 12<sup>th</sup>. It is where they put all the legislative group, from this area, on a television screen to discuss bills and answer questions.
